Analysis of Vaccine Safety Claims THE HPV PLACEBO GROUP Flowchart #3

PLACEBO STUDIES: Before a drug can be registered, the legal requirement is proof of efficacy in adequate and well-controlled trials. Randomised, double-blind, placebo-controlled clinical trials are currently held to be the best way to demonstrate the clinical effectiveness of drugs. Its methodology relies on the method of comparison of standardized group intervention through which the observed outcome difference between groups (drug/intervention versus placebo) can be attributed to the pharmacological effect of the drug/intervention being tested.

There are two principal functions of a **True Placebo Study**: (1) To distinguish pharmacological effects from the **effects of suggestion**, and (2) to obtain an unbiased assessment of the results of the experiment and/or study,⁴ known as the "**Placebo Effect**". Some researchers suggest that the placebo effect associated with the simple act of ingesting a pill (or in the case of a vaccine study, injecting an inert saline solution) may possibly potentiate the actual physiological effect of the drug (positive interaction),⁵ but such interaction would be in an increased sense or actual wellbeing⁶ and not manifested in chronic illnesses as those listed in vaccine package inserts.

PLACEBOS STUDIES FOR PROOF OF VACCINE SAFETY ARE ETHICAL: While some in the medical field may argue that the use of true inert saline solution placebos in vaccine pre-licensing studies are at odds with the ethical requirement that established therapy may not be withheld from patients, such criteria does not apply to vaccine pre-licensing studies for the following reason: Children and adults used in pre-licensing studies are not "patients", they are "volunteers" (personally or as a parent or custodian of a child participating in the study). No health, medical or other need existed for vaccination prior to the child or adult entering the study, nor was such subject potentially exposed in his area to such virus at the time of the study; therefore, no "necessary treatment" was being denied, nor was it required.

CONCLUSIONS: (1) There is no ethical justification for not conducting true placebo studies, and (2) it is only when conducting true placebo studies that vaccine makers could be able to claim that their vaccines are safe and do not cause injury. Being that no true placebo tests have been done on any vaccine in the CDC Childhood Vaccination Scheduled, then <u>Vaccines Have Not Been Proven to be Safe and they are Most Likely Responsible for our Nation's Childhood Chronic Illness Epidemic, including Autism.</u>⁷

FINDINGS OF FACT AND CONCLUSIONS OF LAW

FLOWCHART #1 VACCINE PRE-LICENSING STUDIES

No childhood vaccine pre-licensing study went through true placebo comparisons. It was done deliberately by the vaccine manufactures to hide vaccine injury. Regardless of this obvious lack of proper safety testing, HHS and its agencies, such as the FDA, CDC, and NIH, lie when they say that the science is clear that vaccines are safe and have been properly tested and proven safe; and the vaccine industry and these agencies refuse to do studies comparing the health of vaccinated against unvaccinated children because their intended misinformation and deception would become evident -- FRAUD IN THE FACTUM¹

FLOWCHART #3 THE HPV PLACEBO GROUP

EXTRAPOLATION

Encephalitis; encephalopathy; measles inclusion body encephalitis; subacute sclerosing panencephalitis (SSPE); Guillain-Barré Syndrome (GBS); acute disseminated encephalomyelitis (ADEM); transverse myelitis; febrile convulsions; afebrile convulsions or seizures; ataxia; polyneuritis; polyneuropathy; ocular palsies; paresthesia; disseminated mumps and rubella vaccine virus infection have also been reported. Death has been reported following vaccination.
