## FAILED POLICY OR PURPOSEFUL CONSEQUENCES OF THE GOVERNMENT'S HANDLING OF THE SARS-CoV-2/COVID-19 PANDEMIC ---- HIDING INJURIES AND COMMITTING FRAUD By Pastor Ricardo Beas 1/4/2022



In early 2019, the World Health Organization published a report titled "Ten Threats to Global Health in 2019." In it, they named a "Global Influenza Pandemic" as the second biggest threat, and "Vaccine Hesitancy" as the seventh.¹ This was in preparation for what was coming a year later in 2020, the alleged SARS-CoV-2/COVID-19 (hereinafter COVID-19) Pandemic and the related worldwide lockdown.

For those of us *activists against forced vaccination*, that had been studying and analyzing much of the data showing that all vaccines in the childhood and adult vaccine schedules from the CDC where not effective or safe, but were instead causing many injuries and deaths, the risk overwhelmingly outweighing any benefits,<sup>2</sup> we had already seen an increase in censoring by mainstream social media outlets of our posts, such as Facebook. Mainstream media news outlets and talk shows operate in the same manner, and together their biggest crimes are (1) hiding and denying all the evidence of COVID-19 injuries and deaths, (2) not reporting on the inappropriate, harmful, and deadly hospital treatments those considered to be infected with COVID-19 are receiving, and (3) the attack on any person, medical professional, or scientist speaking in favor of inexpensive and readily-available medications that cure or lessen the symptoms of COVID-19, whether homeopathic ingredients and/or some well-known effective and inexpensive anti-viral/anti-parasitic drugs sold by Big Pharma, such as Ivermectin, Hydroxychloroquine, Budesonide, as well as Aspirin, Vitamin D, and Zinc.

ones to promote the Global Reset-linked **COVID-19 Pandemic Farce**<sup>4</sup> and then they attempt to hide effective cures for COVID-19, as Dr. Fauci and others did when trying to discredit Hydroxychloroquine with an alleged peer-review study that proved to be fraudulent, later retracted by the publisher, The Lancet.<sup>5</sup> **COVID-19 vaccines are causing permanent serious injuries and deaths worldwide.**

2. Whistleblower Deborah Conrad, Hospital Physician's Assistant, revealed that healthcare providers, including hospitals, doctors, and nurses have failed to report massive numbers of

vaccine injuries to VAERS, even though it is required by law. She saw a large increase in pneumonia cases after people started receiving the COVID-19 vaccines. - 13. Worldwide call by the Corona Committee Conference to stop the COVID-19 vaccination program due to injury and death.<sup>20</sup>
- 14. Pfizer admits that COVID-19 vaccine efficacy weakens over time, meaning that the vaccines don't give actual "immunity," but only partial (if any) protection for a limited amount of time and only against symptoms, without preventing the transmission, which they will claim requires boosters for life.<sup>21</sup>
- 15. Nearly 800 reports of heart inflammation after COVID-19 vaccination in US.<sup>22</sup>
- 16. An Al-powered U.S. Department of Defense data analysis program named "Project Salus," which followed health outcomes of 5.6 million Medicare beneficiaries, shows that hospitalizations are driven by the vaccinated population.<sup>23</sup>

- 25. By CDC instructions, COVID-19 PCR tests are being run at +40 cycle threshold, dramatically increasing the probability of false positives, as confirmed by Dr. Fauci, who stated in an interview that when doing PCR testing, the odds of getting an accurate result at a 35 cycle threshold or higher was "miniscule." <sup>32</sup>

Now, the word "immunity" has been switched to "protection." The term "vaccine" also got a makeover. The CDC's definition changed from "a product that stimulates a person's immune system to produce immunity to a specific disease" to the current "a preparation that is used to stimulate the body's immune response against diseases." <sup>35</sup>
- 29. Athlete injured by COVID-19 vaccines is attacked for telling his story, becomes suicidal.<sup>36</sup>
- 30. Dr Fauci, as well as the World Health Organization confirm that asymptomatic carriers of COVID-19 do not spread the disease, making masking and PCR testing when no symptoms exist unnecessary to stop the spread of the disease.<sup>37</sup>
- 31. The CDC deceivingly ordered states to fraudulently inflate COVID-19 cases, making one case into 15. See Collin County, Texas, Commissioners Court describing how this will affect their COVID-19 numbers.<sup>38</sup>
- 32. People on live TV, including athletes, are collapsing, and dying out of nowhere.<sup>39</sup>
- 33. The CDC, through the National Vital Statistics System, ordered all medical establishments to code deaths as being due to COVID-19, even if no test is done. The death certificate instructions read in part, "In cases where a definite diagnosis of COVID-19 cannot be made, but it is suspected or likely (e.g., the circumstances are compelling within a reasonable degree of certainty), it is

acceptable to report COVID-19 on a death certificate as "probable" or "presumed" ... Ideally, testing for COVID-19 should be conducted, but it is acceptable to report COVID-19 on a death certificate without this confirmation if the circumstances are compelling within a reasonable degree of certainty." <sup>40</sup>

- 34. Although not reported on mainstream media and social platforms, hundreds of thousands of persons all around the world are protesting against the government-imposed forced vaccination agenda and related lockdowns.<sup>41</sup>
- 35. Pfizer attempts to hide that their COVID-19 vaccines have fetal tissue/DNA so it cannot be used by a person as a justified reason to refuse vaccination.<sup>42</sup>


