**RE: REQUEST TO DEBATE THE VACCINE CONTROVERSY**

---

Dear Dr. Hart,

As you know, I visited your university on August 15, 2019, on the day that Dorit Reiss and Dr. Wonha Kim were going to do a presentation in favor of SB 276, and I was hopeful that the presentation would go on as originally scheduled, and that I would have an opportunity to present my position showing why SB 276 should be defeated, to be presented in any question and answer segment allowed.

**SOME PEOPLE DON'T REALIZE THIS:** If passed, SB 276 will effectively eliminate all medical exemptions (no physician will dare to issue one for fear of losing their license, or jail!) for children that have been injured by vaccines in the past, or are immune-suppressed, as well as eliminating medical exemptions for siblings of such vaccine-injured children. The text of SB 277, which eliminated personal and religious rights to avoid vaccination, technically means: You must be vaccine-injured in order to avoid vaccination. **Now SB 276 takes it one step further. It would mean: *Even if you are seriously injured by a vaccine, you still must continue getting all CDC "recommended" vaccines, maybe with the exemption of the one that caused the most severe "authorized" adverse reaction -- until your body, mind, soul and spirit -- The Temple of God -- can take it no more!***

Once it was clear to me that Mrs. Reiss's conference was not taking place, I visited both you and Dr. Kim to see if you would give me an opportunity to express my views to you and to request that you allow me and other Advocates Against Forced Vaccination to present our views at your university campus on the supposed safety of vaccines, as well as to discuss the actual violation of our personal, conscience, medical and religious rights, which both SB 277 and SB 276 are impinging on, and or to allow us to have a debate with Mrs. Reiss, Kim, you and others, who claim that vaccines are beneficial, and not detrimental, to the wellbeing of all Children of God upon this earth.

In the university's Mission Statement webpage, regarding your **Values**, under **Compassion**, it states, **"Reflecting the love of God through caring, respect, and empathy."** That is what I expected of you and Ms. Kim when I visited you, but I was wrong. You referred to me in a derogatory fashion as

an “anti-vaxxer” several times, refusing to give me any time to express my views, and made it clear that you did not want to give us a fair opportunity to present our views or debate the vaccine issue. When I asked Ms. Kim when it would be a good time to talk about this, she basically said, never.

None of my actions before you and any of your staff, students, and or visitors, while I was visiting, were disrespectful or threatening, and yet five minutes after leaving your office I was surrounded by security guards, asked to leave and escorted to my vehicle, in a publicly embarrassing and shameful way. One of the officers confirmed that they were contacted by radio and asked to get me off campus.

When I first heard of Mrs. Reiss’ presentation, I called the number provided in the publicity sign regarding the event (909-558-7478) and the lady that answered confirmed that both students and the general public were welcome to go to the Wong Kerlee Conference Center, whether or not a presentation was taking place, especially considering how hot it would be outside on that day.

Being that the event was canceled, I decided to film my own presentation to counter Mrs. Reiss’ propaganda to convince others to stand behind SB 276 and the child mandatory vaccine agenda. I had considered recording outside of the center, but due to the heat, luckily, I was authorized by university staff to access the Kerlee Center, and I did. The presentation I did is primarily intended for you and Ms. Kim, so that you can understand in a compassionate, caring, and objective way, our position as to why we sincerely believe that SB 277 and SB 276 will not result in better health for our children, but instead exactly in the opposite: *a consistent upward trend in children’s chronic illnesses.*

The peaceful and well-intended presentation I did at the Kerlee Center is titled, **“Vaccine Facts: Facts to Consider Before Deciding If Vaccines Are Safe and Should Be Mandated.”** Here is the link:

My presentation was done in a manner to present my position, but yet avoid any conflict at the university, and at the same time without being disrespectful to your university, its hospital with its world-famous accomplishments, or the Seventh-Day Adventist Church and its members. It was a mission of God that was placed upon me to seek your help in exposing the truth about vaccination.

Dr. Hart, I am hopeful that you are a man of good, and of God, like probably Ms. Kim and many other physicians that believe that vaccines are a safe and effective way to stop disease; but the truth is that the major vaccine manufacturers, those we so often hear about in the news that have injured our society with their products, like Vioxx and opioid-based substances are lying to and defrauding the public, government agencies, medical institutions, and you into believing that their products are safe, when in fact all their obvious actions and studies prove the contrary, as outlined in my presentation.

God willing, I hope that you will reconsider your position and will give our community of Advocates Against Forced Vaccination an opportunity to present our case in front of the public, cameras rolling, and let the facts speak for themselves. I will gladly speak and or meet with you to discuss the possibility for such a debate, that even Senator Pan recently agreed to have, when he said in a public statement, **“An honest, civil debate grounded in science and facts of the merits of legislation is always welcome.”** This is all we have always been asking for, but never granted properly. Please view my presentation above and contact me so we can make all necessary arrangements, set rules, and invite representatives from both sides to do such a public debate. May God favor the Truth and His Children.
