#### Dear Sir or Madam,

My name is Ricardo Beas, and I am the Pastor of the Natural Law Church of Health and Healing, located in San Diego County, California. I am writing this letter to you on behalf of the Members and Disciples of our church and myself, as well as on behalf of all other Children of God, including the undersigned.

Be advised that requiring any person to receive any or all "supposedly required" SARS-CoV-2/COVID-19 vaccines, hereinafter COVID-19 vaccines,<sup>1</sup> in order to participate in any activity and limit their ability to travel in any way, or any requirement to have any type of passport or identification to prove that any person has been vaccinated in order to participate in such activities, is illegal, unlawful and immoral, and it is a violation of our God-given, Natural, and Common Law rights, as expressed and confirmed in the American Declaration of Independence, and as reflected in the federal and state Constitutions; as well as a violation of The Nuremberg Code and the Universal Declaration on Bioethics and Human Rights. Further, such COVID-19 vaccination is unnecessary as it will not help in stopping the alleged COVID-19 Pandemic. I base the above on the following:

#### **1. EMERGENCY USE AUTHORIZATION LIMITATIONS**

All COVID-19 vaccines are under an Emergency Use Authorization (EUA) and cannot be made mandatory. On its website, the U.S. Food and Drug Administration (FDA) notes the following:

"FDA must ensure that recipients of the vaccine under an EUA are informed, to the extent practicable given the applicable circumstances, that FDA has authorized the emergency use of the vaccine, of the known and potential benefits and risks, the extent to which such benefits and risks are unknown<u>, that they have the option to accept or refuse the vaccine</u>, and of any available alternatives to the product."<sup>2</sup>

As noted in the paragraph above, vaccines under an EUA cannot be made mandatory, and all persons have the right to use any available alternative to such vaccines, many of which are now available to the public and which have been used successfully.

Further, even if any of the COVID-19 vaccines are ultimately authorized for use by the FDA, no government agency can make such vaccines mandatory for the reasons stated herein.

## 2. THE SO-CALLED COVID-19 VACCINES ARE NOT VACCINES, BUT A GENE THERAPY

The so-called COVID-19 vaccines are a dangerous experimental gene therapy that has not been properly tested for short-term and long-term side effects. As noted by Dr. Steven Hotze, M.D.:

"The so-called COVID-19 "vaccine" is not a vaccine at all. It is an experimental gene therapy. The Center for Disease Control (CDC) gives the definition of the term vaccine on its website, <u>https://www.cdc.gov/vaccines/vac-gen/imz-basics.htm</u>. A vaccine is a product that stimulates a person's immune system to produce immunity to a specific disease. Immunity is the protection from an infectious disease. If you are immune to a disease, you can be exposed to it without becoming infected.

This so-called COVID-19 "vaccine" does not provide the individuals who receive the vaccine with immunity to COVID-19, nor does it prevent the transmission of this disease. It does not meet the CDC's own definition of a vaccine. That is why it is a deceptive trade practice, under 15 U.S. Code, Section 41 of the Federal Trade Commission, for pharmaceutical companies who are producing this experimental gene therapy, to claim that this is a vaccine."

Being a gene therapy, such mislabeled COVID-19 vaccines, cannot be made mandatory or made a requirement in order to participate in any private or public activity.

## 3. THE COVID-19 VACCINES DO NOT STOP THE TRANSMISSION OF THE VIRUS

The only reason why any government authority or organization would require COVID-19 vaccination among the population is to stop the spread/transmission of the disease, so that those vaccinated would not get the virus and would not spread the virus. **The COVID-19 vaccines do not stop transmission of the virus and** <u>are only intended to reduced symptoms of the disease</u>. This has been confirmed by Dr. Anthony Fauci from the National Institute of Health, who stated in a recent interview the following:

"... And that's the primary endpoint of most of the virus (COVID-19 vaccines); is to prevent clinical disease, <u>to prevent symptomatic disease</u>, not necessarily to prevent <u>infection</u>." <sup>4</sup>

This also addresses the issue that because the COVID-19 vaccines don't stop transmission, then they cannot help the community in any way to reach heard immunity; heard immunity will only be accomplished through natural herd immunity, making the vaccine totally useless to stop the spread of COVID-19.

Further, by pushing and requiring COVID-19 vaccination, we are increasing the number of vaccinated persons that are and will be spreading the disease in the community without realizing it, because they are not experiencing COVID-19 symptoms due to vaccination, and the vaccines do not stop transmission of the virus. If such persons were not vaccinated and they had such visible common cold symptoms, it is more likely that they would have stayed at home and started treatments as necessary and others would maintain their distance.

# 4. PERSONS THAT HAVE RECEIVED THE VACCINE HAVE CONTRACTED COVID-19

As noted in 3 above, the COVID-19 vaccines do not stop transmission of the disease. This also means that the vaccines do not stop a person from getting infected with the virus; therefore, it makes no sense to require a person to get a vaccine in order to stop them from getting or transmitting the disease, because such vaccines don't stop you from getting infected. This is confirmed by multiple reports of persons that are fully vaccinated with the COVID-19 vaccines and still catch such virus, including one titled *"Over 100 Fully Vaccinated People in Washington State Test Positive for COVID-19."* <sup>5</sup> Thus, not having been vaccinated does not increase or decrease the chances of a person from getting infected or transmitting it.

# 5. NATURAL ASYMPTOMATIC CARRIERS DO NOT SPREAD THE VIRUS

It is well known and established in science that in the case of viruses, such as the coronaviruses, that persons that show no symptoms of the disease, such as sneezing, coughing, sore throat, and high temperature, are not spreaders of the disease. This has been confirmed both by Dr. Fauci,<sup>6</sup> as well as confirmed by authorities of the World Health Organization, WHO.<sup>7</sup> Further, a scientific study of 10 million people in Wuhan, China, published in November 2020, found that asymptomatic spread of COVID-19 did not occur at all.<sup>8</sup>

Based on this, a person that might have been exposed to COVID-19, if that person does not show any symptoms, such person will not infect anyone else when traveling and visiting, whether visiting a healthy person or a person that is in a hospital or nursing home due to pre-existing medical issues. Further, in these scenarios, if face coverings work to stop the spread of COVID-19, as health authorities claim, then such visiting person can, at most, use facial coverings, and could easily follow good hygiene etiquette when visiting such persons without the need of a COVID-19 vaccine.

#### 6. PASSPORTS OR SIMILAR VACCINATION DOCUMENTS ARE ILLEGAL

As noted and proven above, the COVID-19 vaccines will not help a community in any way to avoid getting its members infected with SARS-CoV-2/COVID-19, nor will it help to stop its transmission to others, and as a result, these vaccines will not help a community in any way in reaching any sort of artificial herd immunity. To put it bluntly, COVID-19 vaccines are useless in stopping what authorities call the COVID-19 Pandemic, making it unnecessary to get a vaccine, and even less to have a need for some sort of physical or digital identification to track such vaccination status, and it would be illegal to limit anyone's activities and visits to public or private places based on such vaccination status.

Further, whether a person gets vaccinated or not, or what their medical history is, such information is private information protected under numerous federal and state laws, including the *Health Insurance Portability and Accountability Act*, HIPPA, which is a federal law that requires the protection of sensitive patient health information from being disclosed without the patient's consent or knowledge.

If any government agency, business or organization requests proof of vaccination from any person, then they are requesting private information. If such entities refuse any or all services to such person for lack of proof of such vaccination, or a negative COVID-19 test, then they are discriminating against such person for wanting to protect their medical information and privacy rights, also reflected in the 4<sup>th</sup> Amendment to the U.S. Constitution, and they are violating federal and state law.

# 7. COVID-19 VACCINES ARE CAUSING IRREPARABLE DAMAGE AND DEATH IN SOME CASES

There have been tens of thousands of minor, moderate and serious chronic illnesses, as well as thousands of deaths reported worldwide related to the COVID-19 vaccines, which have resulted immediately or within a short period of time after vaccination. Health agencies and vaccine manufacturers have rushed to declare that no such evidence of COVID-19 vaccine injury exists, claiming that such injuries are anecdotal. This same fraudulent excuse has been used by such entities to claim that child vaccines are effective and safe, and therefore that parents are wrong or delusional when they claimed that a vaccine or multiple vaccines administered in one doctor's visit injured their child. This is a complete lie and cover-up, regardless of how distasteful such a statement may be. Here is our evidence:

## (a) Adverse Anaphylaxis and Other Reactions to COVID-19 Vaccines

A recent study on a COVID-19 vaccine found *"severe reactions consistent with anaphylaxis occurred at a rate of 2.47 per 10,000 vaccinations."* <sup>9</sup> Anaphylaxis is a severe, potentially life-threatening allergic reaction. It can occur within seconds or minutes of exposure to something a person is allergic to. Anaphylaxis causes your immune system to release a flood of chemicals that can cause you to go into shock — your blood pressure drops suddenly and your airways narrow, blocking breathing.

In January 2021 in San Diego, CA, a vaccine center was shutdown after 6 healthcare workers had serious allergic reactions to vaccines.<sup>10</sup> In April 2021 A mass vaccination site at Dick's Sporting Goods Park in Colorado was shut down after several adverse reactions to the Johnson & Johnson COVID-19 vaccine.<sup>11</sup> Three more vaccination centers have also shutdown recently, in Iowa, Georgia and North Carolina.<sup>12</sup>

### (b) Vaccines in General Have Not Been Studied Using True Saline Placebos.

Vaccines have never been tested against actual true saline solution placebos, making it impossible for anyone to make such a claim of proven vaccine safety. Instead of using true placebos, vaccine manufacturers compare vaccines with other vaccines, and in some cases use neurotoxic substances like aluminum in their "placebo" solutions.<sup>13</sup>

#### (c) The Parsimony Principle Points to Vaccines as the Culprits of Many Diseases and Deaths

The Parsimony Principle is basic to all science and tells us to choose the simplest scientific explanation that fits the evidence. In the case of childhood vaccination, we see this scenario play out repeatedly. A child who is in perfect health, with no preexisting medical conditions, goes for his/her "wellness" (*vaccination*) visit. The doctor examines the child, claims the child is in perfect health, recommends or convinces the parent to give the child either 1 or up to 10 vaccines at the same time to take advantage of the doctor's visit. The child either immediately or soon thereafter develops a serious chronic disease or dies. The Parsimony Principle point directly and unequivocally in the directions of vaccination.<sup>14</sup>

The best, but unfortunate example of the dangers of vaccination is the story of triplets who succumbed to serious life-long neurological injury hours after vaccination on the same day, one after the other.<sup>15</sup> The same is happening with healthy persons that take the COVID-19 vaccines.

The COVID-19 and all other vaccines fall in this category, they are medical interventions and vaccine industry-promoted procedures that because of their potential for injury, cannot be forced upon the population. In a recent CDC guidance publication related to making COVID-19 PCR testing mandatory for childhood schooling, the CDC noted:

"When testing is not recommended? If a school is implementing a testing strategy, testing should be offered on a voluntary basis. <u>It is unethical and illegal to test someone</u> <u>who does not want to be tested</u>, including students whose parents or guardians do not want them to be tested." <sup>16</sup>

Taking this statement to the next level, it means that if simply testing with a supposedly sterilized swab cannot be made mandatory, else it would be unethical and illegal, then coercing or forcing anyone to take a vaccine that can be much more harmful and deadly than a PCR swab would be much more unethical and illegal.

# (d) The Experimental COVID-19 Vaccines Are Causing Irreparable Harm Around the World and Yet Are Being Forced Upon the Population

Since the 2019 World Health Organization attack on anyone against forced vaccination, calling them one of the ten threats to global health,<sup>17</sup> and after U.S. congressional demand that any social media posts, comments, publications, and debate on vaccines be curtailed to only pro-vaccination promotion, and

propaganda,<sup>18</sup> the mainstream and social media giants have followed a campaign to completely censor and/or ban any questioning of vaccine safe, government vaccination programs, any vaccine criticism, doctor's testimonies of the dangers of vaccines, information on treatments for COVID-19, and in particular any publication that exposes the true dishonest and fraudulent nature of this ever-evolving and changing COVID-19 pandemic, whose more appropriate name should be "PlanDemic" based on all the evidence now pointing in that direction.<sup>19</sup>



The mRNA vaccines are a new type of vaccine that trigger an immune response in different areas and cells in the body, as opposed to prior vaccines that contain and introduce a weakened or inactivated germ into our bodies. They instruct our body to make a "spike protein", for which the body produces antibodies, making our body attack itself, with unknown short-term and long-term consequences.

## NOTICE OF LIABILITY TO ALL BUSINESSES AND ORGANIZATIONS

While I would like to continue a cordial relationship with your establishment and staff, refusal to allow me into your premises due to lack of COVID-19 vaccination will be considered a violation of our legal rights, as stated in federal and state law, such as that noted in California Civil Code 51 (b), which reads as follows:

"All persons within the jurisdiction of this state are free and equal, and no matter what their sex, race, color, **religion**, ancestry, national origin, disability, **medical condition**, **genetic information**, marital status, sexual orientation, citizenship, primary language, or

# immigration status are entitled to the full and equal accommodations, advantages, facilities, privileges, or services in all business establishments of every kind whatsoever."

Other violations include rights covered by the American Disabilities Act, US CODE Title 18, Section §242, and Deprivation of Rights under Color of Law. See also 42 USC 2000a.

### WARNING TO ALL GOVERNMENTAL, PUBLIC AND PRIVATE ENTITIES AND PERSONS

#### Based on the above, and on behalf of all those named and referenced herein:

- (a) No business or organization, including any governmental agency has the authority to force me or anyone else to take any and all COVID-19 vaccines, as well as any other vaccine;
- (b) No business or organization, including any governmental agency, has the authority to deny me any and all services provided to COVID-19 vaccinated individuals;
- (c) Denial of any such services, will be a violation of our God-given, Natural, Common Law, state and federal constitutional and international rights not to be vaccinated in any way or form without our consent, this includes our right not to be tracked based on our vaccination status; and
- (d) Any such government agency, business or organization, person's acting as offices of such entities, man and/or woman, violating our right not to vaccinate against COVID-19 will be liable under tort law and for deprivation of rights under color of law, and will be subject to lawsuits, accordingly. A tort, in common law jurisdiction and otherwise, is a civil wrong that causes a claimant to suffer loss or harm, resulting in legal liability for the person who commits the tortious act. It can include intentional infliction of emotional distress, negligence, financial losses, injuries, invasion of privacy, and many other things.

In summary, no COVID-19 vaccination can be required in order to operate in community and social life, whether it is to go shopping, to work, to visit recreational areas, to visit persons in medical establishments, to travel, to visit restaurants or any business, or to enjoy are God-given right to go about our lives without government or corporate interference.

Failure to respect and and any intent to violate anyone's right not to receive any vaccine for COVID-19 or any other disease may and will result in legal action against those involved:

- (1) In the case of government officials, coercing and forcing any person to take such vaccines is a violation of your Oath of Office, your obligation to protect our constitutional rights, and will strip you of any and all governmental immunity for acting outside of your authority; and
- (2) In the case of any business and organization, man or woman, coercing and forcing any person to take such vaccination in order to provide any services or to provide access to your establishment, will be considered a violation of constitutional rights, subjecting your business or entity, and you as a private citizen, a man or a women, to legal action against all of your assets. Business and organization policies are not above the law. LEGAL NOTICE: If I am compelled or forced to vaccinate to receive your services and I am injured, it will be considered coercion, duress and against our will, and you will be held liable for any such injury.

I note here that we are not refusing vaccination, we are simply declining such vaccination for the reasons noted herein, and as mandated by God, the highest legal authority.

Be advised that it is not our intention to harass, intimidate, offend, conspire, blackmail, coerce, or cause anxiety, alarm or distress. This letter is presented with honorable and peaceful intentions and is expressly for your benefit to provide you with due process and a good faith opportunity to correct your behavior and to avoid legal action that will follow if you insist in violating our rights as noted herein.

Act accordingly. Please advise me and/or the undersigned below by email as to how you intend to proceed on this matter so we can proceed accordingly.
