RE: **School Policy Eliminating Student
Religious Exemptions to Vaccination**

Dear Elaine and Katie,

My name is Ricardo Beas and I am the Pastor of the Natural Law Church of Health and Healing. I am writing to you today on behalf of parents in your school that are being affected by your school's new proposed policy to no longer allow religious exemptions to vaccination in order for their children to attend school, even though the state of Missouri laws allows such exemption. The involved policy is titled "STUDENTS: Immunization Requirements", DSR 5105, revised January 2019. See Attachment 1.¹

According to documentation I obtained you plan on implementing this "no religious exemption" policy, hereinafter the vaccine policy, on July 1, 2019, and such policy was developed by the Catholic School Office, with the support of Bishop McKnight.

In support of your decision to apply the vaccine policy, you provide documentation titled Frequently Asked Questions from the National Catholic Bioethics Center on the Use of Vaccines (see Attachment 2), which further references and is a reflection of the Pontifical Academy letter and study of June 9, 2005, at <http://tinyurl.com/Pontifical-Academy-Vaccines>. I want to address both documents here to prove to you that, regardless of your references and on multiple levels it is incorrect, immoral and against the law for you to require and mandate vaccines on children whose parents are against such vaccinations based on personal, conscience, medical, religious beliefs and/or legal reasons as established in Natural Law, Common Law, Constitutional Law, International Law, and Ecclesiastical Law.

Be advised that If you proceed to implement your vaccination policy as noted above, you personally and your organization as a whole may and will be held liable for violation of constitutional rights, and if any injury is suffered by a child who was coerced to vaccinate in order to attend school, even criminal action may apply. See 18 U.S.C., section 241, Conspiracy against rights, and section 242, Deprivation of rights under color of law.

NATIONAL CATHOLIC BIOETHICS CENTER’S FAQ ON THE USE OF VACCINES – A RESTATEMENT OF THE PONTIFICAL ACADEMY LETTER AND RELATED STUDY ON VACCINES

The National Catholic Bioethics Center’s FAQ document, hereinafter the FAQ, starts with the misleading statement claiming that vaccines have a “distant historical association with abortion.”

While the WI-38 and MRC-5 cell line is still in use, many other aborted fetuses are being used for new vaccine research and sale, and are anticipated to be the new wave of vaccine focus in the future. For example, in China, a new fetal cell line from live aborted fetuses emerged for vaccine production. Yet, the issue is not if the vaccine line is from one or two fetuses as the FAQ claims, many fetuses are being destroyed/murdered in the most horrendous ways when doing all the initial clinical studies. The FAQ makes it clear, “Abortion is a grave crime against innocent human life.”

In the case of China, WALVAX 2 is the new aborted fetal cell line. WALVAX 2 is taken from the lung tissue of a 3-month gestation female who was ultimately selected from among 9 aborted babies. The scientists noted how they followed specific guidelines to mimic WI-38 and MRC-5 in selecting the aborted babies, ranging from 2-4 months gestation. They further noted how they induced labor using a “water bag” abortion to shorten the delivery time and prevent the death of the fetus to ensure live intact organs which were immediately sent to the labs for cell preparation. In other words, the normally developing fetus was tortured while it was harvested alive. Yet, in this debate on vaccine safety, there are not only concerns with the fetal matter in vaccines, it also includes the dangers of vaccines and how vaccines defile our body with unclean toxic substances, affecting us, making us defile the Temple of God, and therefore being contrary to our religious beliefs and rights; and these dangers of vaccines have been confirmed by the Godfather of vaccines, Dr. Stanley A. Plotkin.

Dr. Plotkin is likely the most knowledgeable person on the subject of vaccines in the world, as the biggest inventor of vaccines, as a representative of the four biggest and many other vaccine manufacturers, is closely associated with government agencies from the CDC to the World Health Organization, is the main force behind the biggest pro-mandatory-vaccine lobby on the net, which includes discrediting any person and/or organizations who is against the mandatory vaccine agenda,² and is conspiring with pro-vaccine advocate Dorit Rubinstein Reiss to manipulate existing established law to pass legislation on a state and federal level to eliminate all religious exemptions to vaccination in schools and workplaces.³

In a recent deposition that Dr. Plotkin did under oath in a child custody case where he represented a father that wanted to vaccinate his daughter against the mother’s wishes and health concerns, Plotkin exposed the fraud perpetrated upon mankind by the largest vaccine manufacturers: Sanofi, Merck, GlaxoSmithKline, and Pfizer, hereinafter BigVaxxPharma.

For example, in the case of the normally developed fetus tissue used in the manufacturing of vaccines, Plotkin tells us how they selected fetal tissue from the heart, lungs, skin, spleen, kidney, and tongue. See Plotkin deposition at time [17:28:59](#). These fetuses were probably harvested while alive.

Plotkin further shows how the FAQ is incorrect where it claims that we are only talking about “one or two fetuses aborted almost 40 years ago.” Plotkin also initially declared that maybe two aborted fetuses were involved, but upon further questioning, he admitted that in simply one study they used 76 fetuses, then admitted that he had been involved in many such studies, but refused to admit to how many. Further, while descendant cells are not the cells of the aborted child itself, they are derived from and exist because of the original healthy aborted fetus, they do not grow independently from the act of abortion. These cell lines contain DNA from the original aborted fetus, not to mention having been associated with abortions of many other fetuses before the WI-38 and MRC-5 cell lines were chosen. The FAQ says that vaccines are “purified” and that “one cannot accurately say that the vaccines contain any of the cells from the original abortion.” **That also means that one cannot accurately say that the vaccines DON’T CONTAIN any such cells from aborted babies, and I contend that they do.**

Fetus DNA that is contained in vaccines can also cause autism. A study published in the September 2014 volume of the Journal of Public Health and Epidemiology reveals a significant correlation between autism disorder (AD) and MMR, Varicella (chickenpox) and Hepatitis-A vaccines. Dr. Deisher's team discovered that the fetal DNA levels ranged anywhere from 142ng – 2000ng per dose, way beyond the so-called "safe level".

"There are a large number of publications about the presence of HERV (human endogenous retrovirus – the only re-activatable endogenous retrovirus) and its association with childhood leukemia & lymphoma," noted Dr. Deisher. *"The MMR II and chickenpox vaccines and indeed ALL VACCINES that were propagated or manufactured using the fetal cell line WI-38 are contaminated with this retrovirus."* See <http://www.lifenews.com/2014/09/09/study-links-autism-to-vaccines-made-with-cells-from-aborted-babies/>.

There is no excuse for manufacturing vaccines with the use of fetal tissue. Being that some vaccines exist that are not manufactured using fetal tissue means that there is a way to do so, and BigVaxxPharma's refusal to create only vaccines that do not contain fetal matter is the result of a culture of company executives and their lackeys in governmental agencies, such as the Centers for Disease Control and Prevention (CDC), having no moral compass when it comes to their products. Plotkin said that he was an atheist and would gladly go to hell for having used aborted fetuses. See Plotkin at [17:30:45](#). BigVaxxPharma has had 70 years to correct its ways and refuses to do so.

Plotkin and the vaccine industry he represents, who made simply \$30 billion in sales in 2017 (at [10:54:33](#)) further believe that a person does not have a personal, conscience and/or religious right to avoid vaccination, all contrary to constitutionally protected rights. Plotkin does not believe a person can have a valid religious objection to refusing vaccination; see [17:44:54](#).

The FAQ states that “One is morally free to use the vaccine regardless of its historical association with abortion” and that this should be based on “the risk to public health, if one chooses not to vaccinate, (which) outweighs the legitimate concerns about the origins of the vaccine” and correctly state that we all have an obligation to protect the life and health of children and all those around them. What the FAQ does not address is all the proven dangers of vaccines.

As to autism, the vaccine industry and the regulatory agencies it controls like the CDC claim that the reason for the increase in autism from one in 10,000 in the 1980s to 1 in 36-50 today is unknown, but the increase in autism coincides with the increase in the number of vaccines in the CDC vaccine schedule since then. If you ask BigVaxxPharma representatives or the CDC what causes autism they will say they don’t know, but will also tell you it is not the vaccines. **IF THEY DON’T KNOW WHAT CAUSES IT, HOW CAN THEY KNOW IT IS NOT THE VACCINES?** This is a complete contradiction, as well as illogical, and proves the foundation of the vaccine industry fraud. Nothing could be recorded nor would be added to the studies' findings after that short period. See the following confessions from Plotkin:

Vaccines are so toxic that BigVaxxPharma refuses to do true placebo double blinded tests, where a group of vaccinated children would be compared to unvaccinated children. Instead, they use all sorts of trickery to hide such toxicity; for example, (1) by giving one group the vaccine and the other group receiving all the adjuvants/toxic ingredients in the vaccine except the virus, and (2) by giving one group the vaccine and the other group other vaccines with similar adjuvants.

Only in the HPV vaccine study did they have one group of true placebo subjects, but when they came out with zero adverse reactions, they were combined with the group that had the adjuvants, including aluminum. The FAQ further does not address all the small, minor and severe reactions and even deadly effects of allowing oneself to be vaccinated. Nervous tics, allergic reaction, face edema, swelling face, pruritus, rash generalized; nausea, diarrhea, cellulitis, bronchiolitis, urinary tract infection, acute gastroenteritis, asthma, aspiration, breath holding, influenza, inguinal hernia repair, viral syndrome, URI, croup, thrush, wheezing, choking, conjunctivitis, pharyngitis, colic, colitis, congestive heart failure, severe migraine with unilateral facial paralysis; nerve compression in neck and arm, paraesthesia, hypoesthesia, facial palsy, convulsion, syncope, myelitis, anaphylactic and anaphylactoid reactions (can kill you); systemic lupus erythematosus (SLE), Guillain-Barre syndrome; multiple sclerosis, arthritis pain in extremity, tachycardia, encephalopathy, coma. Collapse or shock-like state, fainting, decreased level of consciousness, prolonged seizures, progressive neurologic disorder, including infantile spasms, uncontrolled epilepsy, or progressive encephalopathy, anaphylaxis (death can occur within 30 minutes of onset). Sudden Infant Death Syndrome (SIDS), and Death.

This study compares the CDC flyers for each vaccine with its related insert, proving that the CDC helps BigVaxxPharma hide the dangers associated with vaccination, by making such general statements such as that vaccines are “very safe”, that “most people do not have any problems with it” and that “severe allergic reactions are believed to occur about once in 1.1 million doses” as in the case of the fact sheet for the Hepatitis B vaccine.

BigVaxxPharma also claims and insists that vaccines do not cause autism, but what they don’t publicly admit is that of the 16 or so vaccines on the CDC’s schedule, only one has been actually tested to see if it causes autism, the MMR vaccine, and in that study the CDC’s own scientist William Thompson who was involved in the study confessed that he and those involved in the study were ordered by their superiors to destroy evidence that proved that indeed a vaccine-autism link did exist with the MMR vaccine.⁵

THE HOLY BIBLE SHOULD BE YOUR GUIDE -- NOT THE PONTIFICAL LETTER

The FAQ references a statement by the Pontifical Academy for Life issued on June 9, 2005, regarding the manufacturing and use of vaccines and points to it as the justification for the Church for supporting the use of vaccines with fetal matter and toxic and deplorable unclean content. Yet, to a Christian, Catholic or otherwise, the teachings of God and our obligation to obey God, do not come from, are not defined by and are not reflected in the words and/or writings of ordinary men, including church members who are fallible and subject to temptation and evil, as we have seen in the priests’ nun sexual abuse case and the many child abuse scandals presently engulfing the Catholic Church; instead, **our guidance comes directly from God through the Holy Bible.**

Even the Pontifical Academy states in its study the following:

“It is up to the faithful and citizens of upright conscience (fathers of families, doctors, etc.) to opposed, even by making an objection of conscience, the ever more widespread attacks against life and the ‘CULTURE OF DEATH’ which underlies them” (the use of aborted fetal tissue by manufacturers).

The study also states the following:

“Therefore, doctors and fathers of families have a duty to take recourse to alternative vaccines.”

The above statement is incorrect: the duty is to avoid vaccines. There is no duty from God to take vaccines, God provides what we need from nature and therefore homeopathic and natural alternatives to vaccines should be the first defense against disease. This is clear in the Bible, as noted in the following passages:

The FAQ states that *“One must follow a certain conscience even if it errs, but there is responsibility to inform one’s conscience properly.”* That is exactly what the Advocates Against Forced Vaccination have done, informed themselves of all the dangers as exposed herein, whereas you and your school have not taken the time to study in depth everything that is involved when it comes to vaccine dangers and the agenda to force it upon the United States Population.

The FAQ continues by saying that *“There would seem to be no proper ground for refusing immunization against dangerous diseases.”* Such conclusion is incorrect and misleading, because as has been proven herein:

- (1) Vaccines defile the body, the Temple of God, and God tell us that ***“If any man defile the temple of God, him shall God destroy; for the temple of God is holy.”***
- (2) The proper grounds to avoid vaccination by some of your school parents are based on the known and proven dangers of vaccines as exposed herein.
- (3) The potential for injury resulting from vaccination is much greater than the risk of not vaccinating.
- (4) **VACCINES DO NOT IMMUNIZE ANYONE AGAINST DISEASE!** To be immunized means that our body has become immunologically prepared to successfully fight a particular disease upon entry into our body; and therefore, if vaccines actually immunized a person against a disease, there would not be a need for booster shots, and yet most vaccines require booster shots; and the CDC and state agencies, under profitable recommendation by the vaccine manufacturers, can increase the frequency of vaccination of any given vaccine, as they have done in California after SB 277.

(5) Unvaccinated children are healthier than vaccinated children.⁶

FORCING VACCINE MANUFACTURERS TO STOP USING FETUSES AND THEIR CELL LINES

The FAQ and Pontifical Academy letter state that we should write the vaccine manufacturers and request that they stop using fetuses for their research and the existing fetal lines for their vaccines, but they have known the opposition to this for 70 years and they refuse to do so, and rarely admit the use of such fetal tissue in the manufacturing of vaccines.

One hundred or one thousand letters/emails to the vaccine manufacturers from those taking the time to inform themselves and to write such letters will not make them stop using such fetal matter, not in an industry that makes billions of dollars annually, pays people like Plotkin millions of dollars to further the lie of supposed vaccine safety and rare reactions to such vaccines, and in which the vaccine industry has bought-off state, federal and international health agencies, as well as academia and the medical establishment to perpetuate such fraud against mankind, God and His creation.

It should be the Catholic Church itself, with its global influence, who should be demanding this change, together with all the involved national and global health organizations, as even in its letter the Pontifical Academy state that this practice of using aborted fetuses in the manufacturing process of vaccines is an “illicit action ... which (manufacturers) produce them in an immoral way.”

ACTIVE AND PASSIVE PARTICIPATION IN MURDER

There is no minor, intermediate or major level in being involved in murder. Murder is Murder. If we know about it and do nothing and participate in it in any way, then we are accomplices to such a crime. Trying to be healthy is no excuse for murder, regardless of the level of participation.

Be advised that if such donation by any entity influenced your decision to imposed coerced vaccination for your students in order to attend your school, you could further be charged with multiple racketeering charges under federal civil and criminal R.I.C.O. provisions.

In the greater general sense, throughout the FAQ and the Pontifical Academy letter it tells the reader to use his/her conscience and religious beliefs to avoid vaccination where possible. In the state of Missouri, a parent is allowed to avoid vaccination based on religious beliefs. If parents choose that option, but your school prohibits it and gives them no other option but to vaccinate or not be enrolled, then you are acting contrary to the supposed intent of the Pontifical Academy letter, to do what is necessary to avoid fetal material in vaccines.

--- James 4:17



I am writing to let you know of a change in policy that will become effective July 1, 2019. This change in policy involves immunization requirements for students of our school and was developed by the Catholic School Office, with the support of Bishop McKnight. Enclosed with this letter is a copy of the new policy.

In the past, we accepted exemptions from immunization on the basis of religious beliefs ("Religious Exemptions") and on the basis of medical contraindication ("Medical Exemptions").

Beginning July 1, 2019, our school will no longer accept Religious Exemptions, but will ONLY accept Medical Exemptions that are confirmed by a statement from a duly licensed physician to support the request for a Medical Exemption.

I realize that there may be some of you who believe that Religious Exemptions are appropriate based upon material that may have been used to create certain vaccines. I am enclosing a document of Frequently Asked Questions from the National Catholic Bioethics Center on the Use of Vaccines that will address this concern.

Based upon this change in policy, prior to the beginning of the 2019-2020 school year, with the exception of appropriate Medical Exemptions, all children enrolled in our school must be appropriately immunized or be in the process of being immunized.

STUDENTS: Immunization Requirements

The Catholic Church supports immunization for the health of children and the common good of public health.

Effective July 1, 2019, all students must be appropriately immunized or be in the process of being immunized. The number of doses required for each vaccine will be in accordance with the regulations established by the Missouri Department of Health and Senior Services. Each school administrator/principal is responsible for completing and maintaining the Summary Report, which is a record of the current immunization status of every student enrolled in the school. This Summary Report is required to be completed and submitted annually to the Missouri Department of Health and Senior Services.

Students may not be enrolled in school unless they are in compliance with the immunization requirements or qualify for a medical exemption as confirmed by a statement from a duly licensed physician that is furnished by the parents or legal guardian of the student. Exemptions on the basis of religious beliefs will not be accepted.

FAQ on the Use of Vaccines

What is the Church's teaching about the use of certain vaccines that have a distant historical association with abortion?

There are a number of vaccines that are made in descendent cells of aborted fetuses. Abortion is a grave crime against innocent human life. We should always ask our physician whether the product he proposes for our use has an historical association with abortion. We should use an alternative vaccine if one is available.

What does it mean when we say that these products are made in "descendent cells"?

Descendent cells are the medium in which these vaccines are prepared. The cell lines under consideration were begun using cells taken from one or more fetuses aborted almost 40 years ago. Since that time the cell lines have grown independently. It is important to note that descendent cells are not the cells of the aborted child. They never, themselves, formed a part of the victim's body.

How does one know when a particular vaccine has an association with abortion?

The cell lines WI-38 and MRC-5 are derived from tissue from aborted fetuses. Any product grown in the WI-38 and MRC-5 cell lines, therefore, has a distant association with abortion. The cells in these lines have gone through multiple divisions before they are used in vaccine manufacture. After manufacture, the vaccines are removed from the cell lines and purified. One cannot accurately say that the vaccines contain any of the cells from the original abortion.

What does one do if a physician recommends one of these vaccines?

Sometimes alternative products, which are not associated with these cell lines, are available for immunization against certain diseases. For example, there is a rabies vaccine (RabAvert) and a single dose mumps vaccine (Mumpsavax) without any association with abortion that are equally safe and effective. If doing so is practical, you should ask your physician to use an alternative vaccine, but there is no moral obligation to use products that are less effective or inaccessible. Parents should check with their physician regarding the efficacy and availability of these and any other vaccine.

Are there any vaccines for which there are no alternatives?

Unfortunately, at present there are no alternative vaccines available in the United States against rubella (German measles), varicella (chickenpox), and hepatitis A. All of these are grown in the cell lines WI-38 and/or MRC-5. (See note #7 of the statement of the Pontifical Academy for Life for a listing of vaccines and their source).

What do I do if there is no alternative to a vaccine produced from these cell lines?

One is morally free to use the vaccine regardless of its historical association with abortion. The reason is that the risk to public health, if one chooses not to vaccinate, outweighs the legitimate concern about the origins of the vaccine. This is especially important for parents, who have a moral obligation to protect the life and health of their children and those around them.

What support is there in Church teaching for this position?

A statement from the Pontifical Academy for Life issued in 2005 holds that one may use these products, despite their distant association with abortion, at least until such time as new vaccines become available.

What can I do to ensure that alternative vaccines will be made available?

You can write to the pharmaceutical companies that make these products and insist that they manufacture vaccines that can be used by all without moral reservation. Also, you can contact your local legislators about your concerns.

Am I free to refuse to vaccinate myself or my children on the grounds of conscience?

One must follow a certain conscience even if it errs, but there is a responsibility to inform one's conscience properly. There would seem to be no proper grounds for refusing immunization against dangerous contagious disease, for example, rubella, especially in light of the concern that we should all have for the health of our children, public health, and the common good.

Won't my use of these vaccines encourage others to destroy human life for research purposes?

Upon use, one should register a complaint with the manufacturer of the products as an acceptable form of conscientious objection. This signals opposition to the wider, morally reprehensible practice of using the unborn as little more than research material for science.

It should be obvious that vaccine use in these cases does not contribute directly to the practice of abortion since the reasons for having an abortion are not related to vaccine preparation.
