**RE: NATIONWIDE DEMOCRATIC PARTY ATTACK ON  
FREE SPEECH, PERSONAL AND RELIGIOUS RIGHTS**

Honorable Representatives, Senators, and Ms. McDaniel,

If there is something that our fellow Americans have learned since the candidacy and then election of President Trump, is that the term "Swamp" as used by President Trump in reference to corruption by some of our government officials, is not only more pervasive than anyone expected, but that it is the heads of the Democratic Party Political Machine, with their cronies in the mainstream Fake Media, who are not only trying to destroy President Trump, but are also all trying to take away our individual freedoms and rights, are a perversion in the eyes of God, and are promoting the destruction of the family unit and all that is dear to most God-fearing Americans.

1. Big Pharma refuses to do vaccinated vs. unvaccinated health outcome studies.
2. In pre-licensing studies, vaccines are only compared to other vaccines or toxins, not with true inert saline placebos.<sup>2</sup>
3. Pre-licensing studies are monitored for short periods of time, like Gardasil: 14 days, Hep A: 14 days; Pneumococcal: 4 and 7 days; Hepatitis B: 5 days; Hib and Polio vaccines: 48 hours; MMR: no studies cited.
4. No vaccine is tested for carcinogenicity or its effects on fertility.
5. Vaccines contain healthy aborted fetus tissue and its DNA, from the heart, lungs, kidney, skin and tongue and the new vaccines will require the fetus to be harvested alive.
6. Vaccines contain toxic substances, including, mercury, aluminum, glyphosate, formaldehyde, GMO's, animal blood, etc.<sup>3</sup>
7. The U.S. has the highest rate of chronic health illnesses in the world, including the following: Type-1 diabetes, asthma and allergies, seizure disorders, multiple sclerosis, infertility, autism, autoimmune issues, cancer, and sudden infant death syndrome. All these illnesses have been linked to vaccines and their ingredients by scientific studies, including the manufacturers' own vaccine package inserts.<sup>4</sup>
8. About 1 in 6 children in the United States had a developmental disability in 2006-2008, ranging from mild disabilities such as speech and language impairments to serious developmental disabilities, such as intellectual disabilities, cerebral palsy, and autism. The rate is much higher now.
