

SUGGESTIONS FOR THE NEXT SB 277 LAWSUIT

VACCINATION AND PERSONAL/CONSCIENCE AND RELIGIOUS FREEDOM RIGHTS

- Religious Rights Best Defense – Noted in Constitution
- No mention of Personal or Conscience Rights, and I contend Illegally
 - **9th Amendment:** *The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.*
 - **10th Amendment:** *The powers not delegated to the United States by the Constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people.*
- God-given rights -- All legal rights derives from such religious rights

- **Declaration of Independence:**

- We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.

- That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed –

- Government and its Employees Work for Us
- All other so-called rights have a foundation on legal precedent and simply restate God's/Natural Law rights established since antiquity, and reflected in the Holy Bible.

- **Common Law**

- The common law of England was largely created in the period after the Norman Conquest of 1066 -- Court Decisions Create Precedent for Future Cases. Yet, cases can be distinguishable; each case is unique.

- **Magna Carta of 1215 - King John of England**

- KNOW THAT BEFORE GOD, for the health of our soul and those of our ancestors and heirs, to the honour of God, the exaltation of the holy Church, and the better ordering of our kingdom ...

- FIRST, THAT WE HAVE GRANTED TO GOD, and by this present charter have confirmed for us and our heirs in perpetuity, that the English Church shall be free, and shall have its rights undiminished, and its liberties unimpaired.

- TO ALL FREE MEN OF OUR KINGDOM we have also granted, for us and our heirs for ever, all the liberties written out below, to have and to keep for them and their heirs.

- The U.S. and CA Constitutions do not create our rights, they simple reflect such God-given religious rights.

- **U.S. Constitution First Amendment:** *Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof*

- **CA: Article 1, Section 1:** *All people are by nature free and independent and have inalienable rights. Among these are enjoying and defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy.*

- **CA Article 1, Section 4:** *Free exercise and enjoyment of religion without discrimination or preference are guaranteed.*

STATUS ON VACCINE CHALLENGES

- Turner/Moxley Case (Ana Whitlow) 2016 – Dismissed without prejudice at Fed D.Ct.
- Sharon Brown – state/fed/state - no appeal to Supreme Court, lack of funding
- Travis Middleton RICO case – appeal dropped – lack of funding
- A Voice for Choice – fed/state – waiting assignment of judges to determine if proceed
- **LACK OF FUNDING:** Anti-Mandatory Vaccination Advocate’s Self-Inflicted Wound

BREAKDOWN OF SHARON BROWN LAWSUIT

- Denied by Superior Court
- On Appeal the Attorney Left at Last Minute
- Did Not Present Oral Arguments – Proposed order: Attorney said he could not overcome
- Denied by Court
- Ordered to Pay Appeals Attorneys fee – **PENALTY – DISCOURAGE FUTURE LAWSUITS**
- Attorney Proposed deal – No Attorney fees, no appeal – Defendant’s accepted.

- **Argument against all defenses:** *“The right to practice religion freely does not include liberty to expose the community or the child to communicable disease or the latter to ill health or death.”*

- **Judicial Notice:** *Took judicial notice “of the safety and effectiveness of vaccinations in preventing the spread of dangerous communicable diseases, a fact that is commonly known and accepted in the scientific community and the general public.” - Brown did not cite authority to the contrary.*

THE NEXT COURT BATTLE: A STRATEGY

JUDICIAL NOTICE

Judicial Notice: *Evidence in some cases without hearing or inquiry, is accepted by a court. It is typically a well-known or notorious or indisputable, proven fact.*

LIKE SHARON BROWN CASE: Ask the Court to Take Judicial notice of these facts and evidence:

(Request Discovery were appropriate)

- PRIMARY: Judicial notice that this lawsuit is distinguishable from the 1905 and subsequent cases (Jacobson, Prince, Bruesewitz, Whitlow, etc.) because some or all of the following have not been considered and ruled on by prior courts:

- Vaccine Manufacturers and CDC have not done long term testing on vaccines

- Vaccine Manufacturers have never published (they may have unpublished work open for Discovery) a pre-licensing study where they have tested a vaccine with a true placebo, always comparisons between other vaccines or other toxic chemicals. The only exemption, in a Gardasil study, the true placebo group had zero contraindications, but that group was mixed with a group that received aluminum and other toxic chemicals to hide the result. - Vaccine Manufacturers and CDC have not done any safety studies, short or long term, of the effects of the Administration of multiple vaccines at the same time.

- Vaccine Manufacturers and CDC have not done any studies comparing the health of vaccinated children compared to unvaccinated children.

- Certain viruses in vaccines are spread by those being vaccinated

- Judicial Notice that in some outbreaks, like Pertussis, only or the majority are vaccinated

- The U.S. Dept. of Health and Human Services violated the law and its obligation to do studies and report on the safety of vaccines recommended by the CDC for +30 years

- Judicial Notice of the multiple side effects of vaccines as listed in the Manufacturer's vaccine box inserts, including but not limited to

Nervous tics, allergic reaction, face edema, swelling face, pruritus, rash generalized; nausea, diarrhea, cellulitis, bronchiolitis, UTI, acute gastroenteritis, asthma, aspiration, breath holding, influenza, inguinal hernia repair, viral syndrome, URI, croup, thrush, wheezing, choking, conjunctivitis, pharyngitis, colic, colitis, congestive heart failure, severe migraine with unilateral facial paralysis; nerve compression in neck and arm, paraesthesia, hypoesthesia, facial palsy, convulsion, syncope, myelitis, anaphylactic and anaphylactoid reactions (can kill you); systemic lupus erythematosus (SLE), Guillain-Barré syndrome; multiple sclerosis, arthritis pain in extremity, tachycardia, encephalopathy, coma, Collapse or shock-like state, fainting, decreased level of consciousness, prolonged seizures, progressive neurologic disorder, including infantile spasms, uncontrolled epilepsy, or progressive encephalopathy, anaphylaxis (death can occur within 30 minutes of onset), Sudden Infant Death Syndrome (SIDS), and Death.

- Judicial Notice that the CDC Vaccine Flyers fail to inform the patient in a meaningful way of all the possible side effects of vaccines as compared to the vaccine inserts.

- Judicial Notice of the toxicity of each individual substance in vaccines, when injecting directly into the body and their side effects, including but not limited to:

- Thimerosal, mercury, aluminum (toxic heavy metals), formaldehyde, glyphosate, GMOs, peanut oil, other live or inactivated viruses, bovine extract, polysorbate 80; Bird, Pig, Cow, Dog, Monkey, Mouse, Worm and Insect cells, tissue and DNA, and aborted fetal tissue.
- Judicial Notice that injecting a toxic substance into the body is thousands of times more toxic in the body than ingesting such toxic substances.
- Judicial Notice that some chemicals in vaccines, such as glyphosate, can easily penetrate the blood-brain barrier and carry other substances with it.
- Judicial Notice that pediatricians receive a bonus of \$400 or more if they are able to
 - Convince their patients to give their children all the vaccines in the CDC vaccine schedule
 - They lose the bonus for a child if there is any VAERS or VSD vaccine injury report filed for that child.
 - The VAERS is underreported by an estimated 90%
- Judicial Notice that toxic substances are always toxic, simply varying in degree
- Judicial Notice that different toxic substances affect people in different ways
- Judicial Notice of all lawsuits against vaccine manufacturers for hiding dangers of vaccines
- Judicial Notice that there is a revolving door of vaccine manufacturer representatives going back and forth between jobs with the manufacturers, HHS, CDC and FDA.
- Judicial Notice of the most recent studies on the negative aspects of vaccines (some mentioned above)
- Judicial Notice that the 1976 swine flu injured thousands of people and killed many and that the CDC promotion to make it a national campaign was based on no confirmed outbreaks of swine flu anywhere in the world, as admitted by the CDC head of the time, Dr. David Sencer.

ADDITIONAL POSSIBLE ARGUMENTS

SB 277 DOES NOT MENTION “RELIGION” OR “RELIGIOUS” RIGHTS IN ITS TEXT. Neither does its predecessors AB 2109 from 2012, and AB 1940 from Gov. Brown Sr.

TEXT IN CALIFORNIA HEALTH CODE – SECTION 4, CIVIL CODE – SECTION 8, AND EDUCATIONAL CODE 21.

HSC Section 4: *“Any action or proceeding commenced before this code takes effect, **and any right accrued, is not affected by this code**, but all procedure thereafter taken therein shall conform to the provisions of this code as far as possible.”*

PLAINTIFF’S ATTORNEYS – VERY IMPORTANT

It is up to the person(s) filing the lawsuit to decide which attorney(s) to represent them, but it is highly encouraged that at a minimum the Plaintiffs Legal Team include **Aaron Siri, from Siri & Glimstad LLP** (see <http://Sirillp.com>), both to depose any witnesses for the plaintiffs and the defense, as well as a trial attorney questioning witnesses in the actual trial.

- Conscience, Personal and Religious freedoms defended
- **Defendants:** School District/Dept. of Education, Congressman/Senator sponsoring Bill, Governor Approving Legislation
- **To Be Determined: If lawsuit should be in form of Civil R.I.C.O.**

TRIAL OR INJUNCTION?

Because in the recent cases the courts have ruled mostly on injunctions, it might be better to focus on trial so that all necessary depositions and discovery can be obtained in preparation of such trial and so that a jury can be the one deciding the case, as opposed to a corrupt judge, as we have seen so far.

PLAINTIFFS MUST CLAIM RELIGIOUS FREEDOM AND RIGHTS

- ***The Most Important Defense because religious rights and freedoms are noted in the First Amendment to the U.S. Constitution***

■ HOW TO PROVE YOUR RELIGIOUS BELIEFS AND RIGHTS AGAINST VACCINATION

- Bible vs. the Christian Church: Focus directly on Biblical scriptures, not a particular religion. It is recommended that these be specifically outlined and that the reference be made using the 1611 King James version (for reasons to long to explain here). - God through his Word, The Holy Bible must be our guide. ***The Bible Declares:***

- ***What? know ye not that your body is the temple of the Holy Ghost which is in you, which ye have of God, and ye are not your own? -- 1 Corinthians 6:19***

Any such action would be taken on behalf of the United States.
