

ILLEGAL TOXIC GEOENGINEERING

Crimes Against Humanity

INTRODUCTION

In writing their recommendations in the 1960s *“Report From Iron Mountain on the Possibility and Desirability of Peace,”* those involved from academia from all sciences and at the highest levels, were not asked to find out what would happen if peace reigned the world and to give concrete solutions to help achieve such noble goal; instead, they were asked what would happen to the Ruling Elites¹ (hereinafter *Deep State*) if such peace happened, what would happen to their power and wealth, and more importantly, if they were to lose such power and wealth, what could be the best way to retain it, regardless of the lies that would have to be told and the manipulation of the masses needed to accomplish it, and without consideration of the consequences to all of Mankind.

The most outrageous of the suggestions was to fake an alien invasion from other planets.² How plausible this suggestion is yet to be seen (especially after the Deep State shut down the world and put us all in masks, with a majority’s trust of the government orders and little objection: The Power of Fear). This would probably be their last recourse. But the one plan that was put in place is what we used to know as Global Warming, which when it did not happen as prophesized by Al Gore, was renamed Climate Change. Poisoning of the air, and of the principal sources of food and water supply, is already well advanced, and at first glance would seem promising in this respect;³ it constitutes a threat that can be dealt with only through social organization and political power. But from present indications it will be a generation to a generation and a half before environmental pollution, however severe, will be sufficiently menacing, on a global scale, to offer a possible basis for a solution.”⁴

In his 1976 book, *The Cooling*, Lowell Ponte explains that the earth was headed into another Ice Age, and this would explain the cold fronts we have been facing in recent years, but the truth is that many if not most of the changes we have seen, like severe droughts in California and elsewhere, are all manmade, with the U.S. military using “**Chemtrails**” (chemical trails, as distinguished from “contrails,” condensation trails) and systems like HAARP (High Frequency Active Auroral Research Program) and other microwave antennas across the world to manipulate the atmosphere and weather by warming the substances contained in chemtrails, including metal nanoparticles of aluminum and other neurotoxic substances.

Presently, the most public voice on the issue of Toxic GeoEngineering/Chemtrails is Dane Wigington, through his website, www.GeoEngineeringWatch.com. One of his most comprehensive videos exposing this crime against humanity is “*Exposing the Global Climate Modification Assault*.”⁵ Michael Murphy also presented overwhelming evidence of the chemtrail agenda in his documentaries, “*What in the World are They Spraying*,” and “*Why in the World are They Spraying*.”⁶

The most recognized geophysicist exposing the effects of chemtrails, writing scientific studies to prove their existence, content, and harm, is J. Marvin Herndon.⁷ Syd Stevens, from SoCal Skywatch, has been documenting, through time-lapsed videos, aerial spraying in San Diego County, CA, since 2019.⁸ An anonymous meteorologist has been documenting weather manipulation throughout the United States since 2007 using National Oceanic and Atmospheric Administration (NOAA) satellite images and weather data, as well as from other sources, clearly showing chemtrail operations throughout the United States, affecting and inhibiting rain fall.⁹

Just like claims of vaccine inefficiency and harm are being censored by social media giants, so too are many reports that show that all the science behind Climate Change is flawed and fraudulent with the complicity of the United Nations and its *Intergovernmental Panel on Climate Change* (IPCC). Below I present all the necessary facts and evidence to prove that chemtrails are not contrails, that such chemtrails are toxic to human life and the earth’s biota, that governments around the world are involved in the toxic spraying and its cover-up, and that it is purposefully being hidden from the public.

Affirmant's knowledge, beliefs and upon information, and if called upon as a witness, Affirmant will testify to their veracity.

PLAIN STATEMENT OF FACTS

4. **Water normally occurs in only three physical states: Solid (ice), Liquid, or Gas (vapor).** In solid water, ice is frozen water. When water freezes, its molecules move farther apart, making ice less dense than water. Liquid water is wet and fluid. Water as a gas is a vapor that is always present in the air around us.
5. **Ice crystals** are solid **ice** particles exhibiting atomic ordering on various length scales and include hexagonal columns, hexagonal plates, dendritic crystals, and diamond dust.¹⁰
6. A **Solid** is one of the four fundamental states of matter (the others being liquid, gas, and plasma). Solid molecules are closely packed. They are characterized by structural rigidity and resistance to changes of shape or volume. Unlike liquid, a solid object does not flow to take on the shape of its container, nor does it expand to fill the entire volume available to it like a gas does.¹¹
7. A **Cirrus Cloud** is a genus of atmospheric cloud generally characterized by thin, wispy strands, giving the type its name from the Latin word *cirrus*, meaning a ringlet or curling lock of hair. This cloud can form at any altitude between 16,500 feet and 45,000 feet above sea level. The strands of cloud sometimes appear in tufts of a distinctive form referred to by the common name of "mares' tails." ¹²
8. **Military Chaff** is a radar countermeasure in which aircraft or other targets spread a cloud of small, thin pieces of aluminum, metallized glass fiber or plastic, which either appears as a cluster of primary targets on radar screens or swamps the screen with multiple returns.¹³
9. **Contrails** (short for "condensation trails") are line-shaped clouds produced by aircraft engine exhaust or changes in air pressure, typically at aircraft cruise altitudes several miles above the Earth's surface. **Contrails are composed primarily of water, in the form of ice crystals.**¹⁴ Contrails are limited in length and disappear seconds (no more than minutes) behind the aircraft creating them and appear as a temporary line-shaped white streak against the sky and disappear as the aircraft advances.
10. If twenty water ice cubes are thrown into an Olympic-size swimming pool filled with ambient temperature water, the ice cubs will soon melt into water, will be at the same temperature as the water in the swimming pool, and will be undistinguishable from the other water in the pool.
11. If twenty water ice cubes are thrown into an Olympic-size swimming pool filled with ambient

temperature water, the water in the swimming pool will not turn into ice and become completely frozen at the temperature of the ice cubes.

12. If twenty water ice cubes are thrown into an Olympic-size swimming pool at ambient temperature, the water in the swimming pool will not turn into ice cubes as those thrown in it.
13. **Contrail Ice Crystals** are made up of solid water in crystal state, one of the three states of water.
14. Being a solid, a Contrail Ice Crystal will be structurally rigid, will not flow nor will it expand to fill the entire volume available to it in the vastness of the atmosphere surrounding it.
15. **A Contrail made up primarily of Water Ice Crystals created at an altitude several miles above the Earth's surface, for example at 35,000 feet,¹⁵ at a temperature around -40 degrees Fahrenheit, will tend to do only one of three things: stay solid, turn into a liquid, or turn into a gas.**
16. As in the example of the water ice cubes and the swimming pool above, after being formed by the reaction between boiling water vapor from an aircraft's exhaust and being subjected to extreme cold temperatures, the contrail ice crystals will remain initially frozen, solid, until shortly thereafter when their temperature coincides with that of the atmosphere around it and other existing water molecules in the air and will leave its crystal solid form and be absorbed by its surrounding atmosphere and will return to a gaseous state, making it invisible and undistinguishable from its surroundings.
17. **A Contrail, being made up of Water Ice Crystals cannot and will not expand in the atmosphere after its initial creation, nor will it react with any of the other gases in the atmosphere to the effect that it would also turn them into solid crystal particles of sorts, giving the appearance that the contrail expanded and was able to cover voluminous areas in the sky, appearing as cloud cover, like fog blankets.**
18. **A Chemtrail (chemical trail), also known as Toxic GeoEngineering, refers to the well-coordinated and purposeful spraying of chemical substances and compounds, organic and/or inorganic, in the sky using clandestine and usually unmarked aircraft, typically at elevations above that of commercial airliners, managed by the U.S. Military, by one or several of its branches, departments, divisions, or the like, and/or by other government subcontractors, for hidden and undisclosed purposes.**
19. It is illogical, as well as chemically and physically impossible for a Contrail to expand in the atmosphere. See the photographs at the end of this writing clearly showing Toxic GeoEngineering trails in the sky, which are claimed by television weather forecasters and Federal and State government authorities, through their publications and communications, that such trails are simply either cirrus clouds, military chaff and/or military jet and airliner

condensation trails, known as **Contrails**, as opposed to toxic chemical trails, properly referred to by the U.S. military and now commonly known as **Chemtrails**, a chemical trail of toxic and undisclosed substances, herein also referred to as Toxic GeoEngineering trails, which are purposefully being released into the atmosphere.

20. The United States federal government and its military have been involved in weather modification activities since at least the 1950's, such as shows in the 1952 United States Department of Defense/Navy training film titled "Naval Concepts of Chemical and Biological Warfare."¹⁶
21. Such clandestine weather modification activities by the United States military took place in Vietnam between 1967 and 1972, conducted from Thailand over Cambodia, Laos, and Vietnam, which purpose was to flood supply lines by extending the monsoon season.¹⁷ The toxic chemical spraying also took place in Cuba between 1969 and 1970 to help destabilize the country by affecting its sugar crops, doing the opposite, stopping rain, and creating drought.¹⁸
22. The United States military and other executive agencies, quasi-governmental agencies, subcontractors, educational institutions, foundations, corporate entities, orthodox media outlets, social media platforms, other world governments, and institutions, through their representatives, and in a fraudulent, conspiratorial and criminal fashion, have developed strategies for cooperating, planning, implementing, hiding, and running the existing Toxic GeoEngineering program in the past, now and in the future. Some examples of this plan include the following evidence:

Defense Fund, The Royal Society, and the World Academy of Sciences.²³

- (f) The Guardian, "*Bill Gates backs climate scientists lobbying for large-scale geoengineering.*"²⁴
- (g) Since at least the 1960s, the United States government has conspired with the Deep State and others to control the world population. One such strategy is to claim a threat from global warming, now referred to as Climate Change, to rally people around such fictitious environmental disaster, supposedly caused by global consumption of petroleum products. See the book "Report from Iron Mountain, on the Possibility and Desirability of Peace," author unknown, 1967, where it recommends the following:

*"Nevertheless, an effective political substitute for war would require 'alternate enemies' some of which might seem equally farfetched in the context of the current war system. - (h) The United States government has been financing Toxic GeoEngineering projects studies through educational institutions, such as Harvard University. See Harvard's Solar geoengineering research program's "FUNDING FOR SOLAR GEOENGINEERING FROM 2008 TO 2018."²⁵

23. Such organizations as noted in 21 above plan strategies and carry out programs of disinformation regarding Toxic GeoEngineering and engage in activities to discredit any person, organization, or scientific paper disclosing and confirming the ongoing clandestine Toxic GeoEngineering agenda. See for example the research paper the *Royal Geographical Society*, titled "*Climates of suspicion: 'chemtrail' conspiracy narratives and the international politics of geoengineering.*"²⁶

24. Similar to *Snopes*, two misleading fact-checking websites specializing in discrediting anyone

claiming the existence of chemtrails started operations around 2007 and 2017, allegedly run by a “science writer, skeptical investigator, and retired video game programmer.”²⁷ The websites are ContrailScience.com and Metabunk.org.

25. Such organizations and individuals related thereto as noted in 21 above have registered patents with the United States Patent and Trademark Office, to further the goals of their Toxic GeoEngineering operations.²⁸
26. The primary substance used in Toxic GeoEngineering, proven by rainwater samples, is coal fly ash, produced by coal burning power plants.²⁹
27. The coal fly ash from power plants, among other possible places (in such form as a powder, flowable fill, water-base chemtrails, slurry, or the like) is transported by railroad, barges, trucks, and other means to military installations, clandestine or otherwise, across the United States for use in the Toxic GeoEngineering effort.³⁰
28. NASA, in conjunction with the U.S. Department of Education and other state and federal agencies, developed misinformation campaigns for school children starting in the late 80’s to indoctrinate such children into believing that Toxic GeoEngineering trails were nothing more than contrails. The project claimed NASA needed children’s help to identify and document contrails, and at the same time the other claimed purpose was to help such children understand cloud formation. In the same fashion, these agencies ran other propaganda campaign for children and adults alike to mislead them as to the true nature of the Toxic GeoEngineering spraying being done by aircraft.³¹
29. Airforce whistleblower Kristen Meghan has made declarations confirming the ongoing Toxic GeoEngineering program coordinated by the U.S. military.³²
30. U.S. Senator for Ohio, Rob Portman, as well as other senators have confirmed the Toxic GeoEngineering activities being carried out by the U.S. Department of Defense, with Portman writing in his webpage the following:

“Washington, D.C. – Today, U.S. Senator Rob Portman (R-OH) was joined by Senator Sherrod Brown (D-OH), Congressman Tim Ryan (D-OH-13), Congressman Bill Johnson (R-OH-6), and Congressman Dave Joyce (OH-14) in urging the United States Air Force to replace the Youngstown Air Reserve Station’s (YARS) 910th Airlift Wing’s current fleet of C-130H aircraft

with new C-130J aircrafts to ensure that the 910th's Department of Defense (DoD)-mandated SPECIALIZED AERIAL SPRAYING MISSION CONTINUES SAFELY AND WITHOUT INTERRUPTION.³³

31. The "History Channel" released a documentary that demonstrates how the Department of Defense is involved in weather modification operations which use Toxic GeoEngineering aerial spraying as part of such system.³⁴
32. The United States, in conjunction with other nations, such as China and Russia, are manipulating the weather.³⁵
33. The United States uses multiple military installations, clandestine and/or otherwise, for Toxic GeoEngineering operations using unmarked airplanes. See "A Few Chemtrail Airstrips Identified" from Global Skywatch.³⁶
34. Plans within the Paris Climate Accords and the United Nations' "Transforming Our World: The 2030 Agenda for Sustainable Development," include strategies for global Toxic GeoEngineering to control so-called global warming.³⁷ It also includes taxing countries to sustain their program, all through the United Nations, using binding agreements.³⁸
35. According to the United Nations' Intergovernmental Panel on Climate Change (IPCC), and other co-conspirators as noted in 21 above, the world is headed for self-destruction due to human activities that have been the main drivers of the alleged global warming, primarily due to the burning of fossil fuels (like coal, oil, and gas) which produces heat-trapping gases. While this future catastrophe that was called Global Warming was popularized by the media in 1988, when extreme cold climate events started becoming common and Al Gore's prediction of a global warming catastrophe did not come true by the early 2000s, the term was publicly changed to Climate Change.
36. If chemtrail operations have been changing our climate for at least the last 30 years, then these chemtrails, in conjunction with electromagnetic radiation and atmospheric manipulation, are

causing the droughts seen in California, with its related wildfires, as well as drought in other parts of the world, proving that general human activity and the use of hydrocarbons is not the cause of global warming – The real culprit it is the Toxic GeoEngineering activities of the government of the United States, together with all those complicit and participating in the spraying agenda. It also means that if chemtrail operations cease, that the weather will return to normal. Thus, such activities should cease and be made illegal immediately.

37. The result of chemtrail activities have been drought, famine, population displacement, death, and billions of dollars in losses to crops and our country's infrastructure, when rain not allowed to fall in California and the West Coast resulted in massive rainfall in the Eastern part of the country.
38. More than 100 different scientific papers show that carbon dioxide's effect on the climate is very small. In addition, 95% of climate software models have turned out to be wrong. The IPCC admitted that it's not possible to predict future climate states.³⁹
39. Michael Mann's "hockey stick" graph defamation lawsuit was dismissed by the Supreme Court of British Columbia. A man-made computer software algorithm generated it, and the algorithm was rigged to produce a hockey stick shape spike, no matter what data was entered.⁴⁰ This hockey stick graph was used by the United Nations and the IPCC to justify their so-called fight against Global Warming.
40. In a 2000 publication NASA admits that climate change occurs because of changes in Earth's solar orbit and other factors, not human activity, such as the use of fossil fuels.⁴¹
41. *Weather Channel* founder John Coleman, debunked the Climate Change fraud, noting in his reporting that the weather has been consistent, and proving that the UN and the IPCC were manipulating data and giving false information to the public in order to sell the idea of global warming, calling it "a myth."⁴²
42. On or around May of 2008, approximately 31,000 signatures from scientists around the world proved that there is no scientific consensus about global warming.⁴³
43. American atmospheric scientist Ken Caldeira and David W. Keith, professor of public policy for the Harvard Kennedy School at Harvard University, have been holding lectures around the world promoting toxic spraying, using different names to describe it, like climate intervention, geoengineering, and solar radiation management. One such presentation was in the *American Association for the Advancement of Science* conference in San Diego, CA (circa 2009), where they were promoting spraying the skies around the world with toxic neurotoxic chemicals of

nanoparticle size, like aluminum, to combat global warming.⁴⁴

44. Eleven years later, on or around October of 2019, a group of 500 prominent scientists and professionals sent a registered letter to the United Nations Secretary-General stating that there is no climate emergency and that climate policies should be designed to benefit the lives of people.⁴⁵ The specific points about climate change highlighted in the letter are:

1. Natural as well as anthropogenic factors cause warming.
2. Warming is far slower than predicted.
3. Climate policy relies on inadequate models.
4. CO₂ is not a pollutant. It is a plant food that is essential to all life on Earth. Photosynthesis is a blessing. More CO₂ is beneficial for nature, greening the Earth: additional CO₂ in the air has promoted growth in global plant biomass. It is also good for agriculture, increasing the yields of crops worldwide.
5. Global warming has not increased natural disasters.
6. Climate policy must respect scientific and economic realities.
7. There is no climate emergency. Therefore, there is no cause for panic.

45. IPCC Chairman Rajendra Pachauri did not timely disclose in the Copenhagen summit on climate change, that suppressed data in one of their reports, about the Himalayas' ice melting and disappearing by 2035, proved that their predictions about global warming were wrong, if not a direct lie, used to push their agenda.⁴⁶

46. The National Oceanic and Atmospheric (NOAA), which measures U.S. temperatures publishes data that is fraudulent. *"NOAA has made repeated 'adjustments' to its data, for the presumed scientific reason of making the data sets more accurate. Nothing wrong with that. Except, all their changes point to one thing — lowering previously measured temperatures to show cooler weather in the past and raising more recent temperatures to show warming in the recent present."*⁴⁷

47. Done criminally and in a conspiratorial fashion, purposefully sprayed chemtrails and toxic geoengineering activities are the primary cause worldwide of the extreme drought and weather changes that have been noticed in the last two to three decades, affecting men, women, and children around the world, affecting their health, their food, and the air they breathe, a crime against humanity. After vaccination, toxic geoengineering is the most harmful mass poisoning campaign against the people of the world by the Elite.

48. Under Natural Law and Common Law, a man, woman, and child retain all rights inherent in his or her incarnation that he or she has not individually, knowingly, purposefully, and with full and informed consent, given away to government, in particular the right to not be injured by government agencies carrying out, taking part in, or covering up for harmful toxic clandestine spraying activities.
49. Affirmant sees no verifiable evidence that a man, woman, or child does not own his or her body, and Affirmant believes no evidence to the contrary exists.
50. Affirmant sees no verifiable evidence that Toxic GeoEngineering is a safe method to control the weather; to the contrary, ample evidence exists to show its detrimental effects on man and woman of all ages, and the environment, and Affirmant believes no non-fraudulent evidence to the contrary exists.
51. Affirmant sees no verifiable evidence that Toxic GeoEngineering shall not be considered “experimental,” and Affirmant believes no evidence to the contrary exists.
52. Affirmant sees verifiable evidence that (a) the substances contained in chemtrails are toxic, and (b) that these chemtrail operations have been modifying our weather to our health’s detriment.
53. The Nuremburg Code, formulated in 1947, unequivocally states:
- a. *“The voluntary consent of the human subject is essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved, as to enable him to make an understanding and enlightened decision.”*
 - b. *“The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury ... In research on man, the interest of science and society should never take precedence over considerations related to the well-being of the subject.”*
54. Toxic GeoEngineering operations result in unsolicited and unauthorized experimentation upon Affirmant and others, without advice and/ or consent, resulting in a violation of the Nuremburg Code.
55. The United States Constitution neither explicitly grants any of the three branches of government the power to require any medical procedure upon any person, nor can the U.S.

Congress or any State violate any man and or woman’s God-given and unalienable rights not to do harm to himself, to be harmed by others, and/or to allow harm to others with proven substances, such as the substances in Toxic GeoEngineering operations as described herein, such Natural Rights reflected in the Common Law.

56. Affirmant sees no verifiable evidence that any law or international agreement requiring Toxic GeoEngineering affecting any man, woman, or child in any circumstance is not outside the authority of the United States Congress to make or enforce, nor any verifiable evidence that any such law shall not be considered null and void, and Affirmant believes no evidence to the contrary exists.
