I, **Your Name**, the Affiant and undersigned, state, certify, affirm and declare the following:

I am writing this letter **under duress and coercion**, in compliance with California Health & Safety Code section 120335 (g)(1), which requires parents seeking to exempt their child from the requirements of the California mandatory school vaccination law Senate Bill 277 to submit, "a letter or affidavit with his or her school (any public or private school) stating their beliefs opposed to immunization" prior to January 1, 2016. This legislation also notes that such letter would become unacceptable once the child moves from 6<sup>th</sup> to 7<sup>th</sup> Grade. This letter is timely and is still valid in that an arbitrary deadline set up by SB 277 and the government officials behind it does not deny nor preclude me or my child from the ability to assert our conscience and religious freedom rights as declared in the First Amendment to the U.S. Constitution at any time.

This letter and affidavit is to inform you and/or the administrator of any future school that my child, the student named above may and should attend school and that the administration of each of the ten enumerated vaccinations made mandatory by SB 277 (measles, mumps, rubella, polio, Hib, Hepatitis B, diphtheria, pertussis, tetanus, and chicken pox) and any future vaccines are **in conflict with, are against, and are a violation of my personal health care philosophy, my personal beliefs, my medical beliefs, and in particular my Conscience and Religious Freedom Rights, beliefs and practices as protected by the First Amendment of the U.S. Constitution.**

Specifically, I have strong religious convictions against vaccination on the following grounds:

- (a) I find the development of modern vaccines using aborted fetal cell lines morally reprehensible—a practice I cannot condone, support, or in any way participate in, and

(b) I also firmly believe, based on evidence I have become aware of, that **some or all of the chemicals contained in all vaccines, such as mercury, aluminum and glyphosate, are detrimental to my child's physical and spiritual health and well-being** and that such vaccines may impact me or any of my children, from the development of physical tics, encephalitis, Guillain-Barre Syndrome, Sudden Infant Death Syndrome, the whole spectrum of Autism and even death, proven by the vaccine manufacturers' own vaccine inserts. To introduce any of the toxic vaccines substances and ingredients described above into the body of any of my children would be to defile their body, which would defile The Temple of God, as my children and I are Children of God, and thus we are God's Temple.

As is noted in the **1611 King James Version of the Holy Bible**, God orders us to protect our and our children bodies from defilement and to reject any laws and or authority that are contrary to God's Laws, from which all subsequent laws are derived – The Law Being That of Precedent, even before Hammurabi, to the beginning of time, as God's Word and Laws precede man's writing of the Holy Scriptures. **Sayeth our Lord:**

“Knowe yee not that yee are the Temple of God,  
and that the Spirit of God dwelleth in you?”

As to the dangers of vaccines, see also declarations made by Centers of Disease Control and Prevention (CDC) scientist and now vaccine-danger whistleblower Dr. William Thompson, which has admitted to the CDC’s corrupt concealment of the dangers of vaccines, of which conspiracy and collusion he was a part of and now regrets and is trying to correct by exposing it.

**TO BE CLEAR, I AM TOTALLY AGAINST AND REFUSE ANY SORT OF VACCINATION FOR MY CHILD, AT ANY TIME, NOW OR IN THE FUTURE, FOR HEALTH, PERSONAL, CONSCIENCE AND RELIGIOUS REASONS AND NO ACTION OR INACTION ON MY PART, IN THE PAST OR IN THE FUTURE, IN FILING ANY FUTURE REQUIRED WRITTEN DOCUMENTS WILL CHANGE THAT.**

**SEPARATELY, I WILL TAKE INSTITUTIONAL AND PERSONAL **LEGAL ACTION** AGAINST ANY ENTITY OR PERSON DEPRIVING MY CHILDREN FROM THEIR RIGHT TO ATTEND ANY SCHOOL OF MY CHOICE SOLELY BASED ON OUR REFUSAL TO RECEIVE VACCINES.**

**BE ADVISED:** Any school principal, District Superintendent, District personnel or any other government employee that violate my conscience and religious freedom rights will lose all governmental immunity for violation of their oath of office, as such actions intended to deprive my children from attending school or attempt to convince or force us to vaccinate my child, are violating my constitutional rights. See Scheuer v. Rhodes, 416 U.S. 232, 94 S.Ct., 1683, 1687 (1974), which states in part:

**"When a state officer acts under a state law in a manner violative of the Federal Constitution, he comes into conflict with the superior authority of that Constitution, and he is in that case stripped of his official or representative character and is subjected in his person to the consequences of his individual conduct. The State has no power to impart to him any immunity from responsibility to the supreme authority of the United States."**

For these reasons I have executed this Vaccine Conscience and Religious Rights Exemption Letter, to (a) affirm that I am against vaccination because it is against my conscience and religious freedoms and beliefs, and against my children's health, and (b) to declare and make clear that I will take legal action against any person and entity that violate my or my children's conscience and religious rights.

The religious rights and responsibilities to maintain a healthy and clean temple/body is a fundamental religious belief that my family and I share, and it is our religious belief and duty to protect ourselves.

The following substances and toxins are found in many, if not all vaccines being administered to the public, and if administered to any of us they would defile our temple, against our and God's wishes:

- **Mercury (thimerosal or otherwise)**
- Formaldehyde -- a known cancer-causing agent
- **Aluminum -- a neurotoxin**
- Triton X-100 -- a detergent
- Phenol (carbolic acid)
- Ethylene glycol (antifreeze)
- **Glyphosate (a California accepted and proven carcinogen)**
- Various antibiotics: neomycin, streptomycin, gentamicin -- which can cause allergic reactions in some people
- The living or dead virus itself which the vaccine is supposed to protect against
- Aborted fetal cells
- Possible Carcinogens (vaccines have never been tested for carcinogenicity, see next bullet)
- Many other substances that the vaccine manufacturers themselves admit cause serious health risks, up to and including death. See children mandatory vaccine inserts summary at <http://www.cafepeyote.com/files/Vaccines - Insert Analysis.pdf>
- Other live and inactivated viruses not related at all with the disease being treated
- Other species' DNA or DNA altering microorganisms

We are not allowing these or any other toxin to be introduced into our temple without our personal consent and I hereby give notice that **I DO NOT GIVE CONSENT for me or any of my family members to receive vaccines, and any intent to vaccinate my children must first be communicated to me for my final approval.**

I further affirm and declare that both the State of California and the United States federal governments have no legal authority to force me and/or my children, natural born men, woman and children, all children of God, as opposed to some artificial/fictitious entity and their agents, to be vaccinated in any way against our will, for whichever reason, and in particular due to my conscience and religious beliefs and rights, and because the only authority over me is God, not a corrupt de jure and/or de facto government that has usurped its authority to regulate men and woman, children of God, regardless of where said alleged and I contend illegal and fraudulent terrestrial authority comes from.

**This is so because my children's and my natural and God-given, natural and common law rights, as well as those rights noted in the First Amendment to the United States Constitution, and California Constitution, article 1, section 4, prohibit the government from impeding the free exercise of religious beliefs.**

I make reference to California Constitution, Article 1, Section 1, which states:

**ALL PEOPLE ARE BY NATURE FREE AND INDEPENDENT AND HAVE INALIENABLE RIGHTS. AMONG THESE ARE ENJOYING AND DEFENDING LIFE AND LIBERTY, ACQUIRING, POSSESSING, AND PROTECTING PROPERTY, AND PURSUIING AND OBTAINING SAFETY, HAPPINESS, AND PRIVACY.**

#### **VIOLATION OF FEDERAL CIVIL RIGHTS AND COMMON LAW RIGHTS**

The Fourteenth Amendment of the United States Constitution guarantees **Religious Civil Rights**. It reads in part as follows:

***"No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.***

The Fourteenth Amendment applies both to the persons "created" under that amendment, "citizens of the United States," as well as to "persons" / "**Private Persons**" under Common Law: **Natural Born men and woman in the Land Jurisdiction** (as opposed to the Sea Jurisdiction, Admiralty/Vice-Admiralty), whose Natural and Common law rights are reflected in, but independent of, the Fourteenth amendment. See Black's Law Dictionary, Revised 4<sup>th</sup> Edition, West Publishing, 1968, definitions of "Private Person" at page 1359, and "Individual" at page 913, distinguishing between natural persons and fictitious, "government created" entities.

**My children, family and I, AS WELL AS ALL CHILDREN ATTENDING SCHOOL, are Natural Born men and woman**, and we are owed protections as those confirmed or implied in the Fourteenth Amendment, against discrimination based on religious beliefs.

**MY RELIGIOUS, ETHICAL AND MORAL BELIEFS, AS IT PERTAINS TO ME, MY BODY AND THAT OF MY CHILDREN, IS THAT ANY FORCED VACCINATION IS AGAINST MY WILL – PROHIBITED BY**

**SUCH CONSCIENCE AND RELIGIOUS BELIEFS AS NOTED HEREIN; AND THAT FORCED VACCINATION, OR BEING COMPELLED TO BE VACCINATED IN ORDER TO BE ADMITTED IN SCHOOL, IS A CRIMINAL ACTION AGAINST MY CHILD BY ANYONE INVOLVED DIRECTLY AND INDIRECTLY IN SUCH FORCED VACCINATION; AND WHEN APPLIED TO TWO OR MORE PERSONS – IT IS A CRIME AGAINST HUMANITY!**

Furthermore, internationally, the Nuremberg Code and Universal Declaration on Bioethics and Human Rights UNESCO prohibits forced medication. Article 6, section 1 states:

***Any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should, where appropriate, be express and may be withdrawn by the person concerned at any time and for any reason without disadvantage or prejudice.***

#### **VIOLATION OF CHILDREN’S RIGHT TO EDUCATION:**

To use SB 277 as an excuse to prohibit unvaccinated children from enjoying their constitutional right to an education, even in times of typical disease outbreaks, is a violation of California law, as noted in the following sections of California Constitution, Art. 9:

##### **Section 1:**

***A general diffusion of knowledge and intelligence being essential to the preservation of the rights and liberties of the people, the Legislature shall encourage by all suitable means the promotion of intellectual, scientific, moral, and agricultural improvement.***

##### **Section 5:**

***The Legislature shall provide for a system of common schools by which a free school shall be kept up and supported in each district at least six months in every year, after the first year in which a school has been established.***

Denying education to unvaccinated children is also a violation of the California Constitution Declaration of Rights, Article 1, section 7, which reads in part:

***“A person may not be deprived of life, liberty, or property without due process of law or denied equal protection of the laws.”***

Further, the compel coerced and forced vaccination and or deprivation of school rights, public and private, regardless of the option of homeschooling, is a violation of Title 18 USC Section 241, “Conspiracy Against Rights” which reads:

***“If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same ...***

*They shall be fined under this title or imprisoned not more than ten years, or both; **and if death results from the acts committed in violation of this section** or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, **they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death**" (as could be the case in a child's death related to vaccination in any way due to school pressure and a parent's attempt to comply with school officials, all in violation of the parent's and child's God-given and civil rights as described herein).*

**NO FORCED AND/OR UNAUTHORIZED VACCINES ALLOWED**

Additionally, because SB 277 and other proposed legislation also allows certain persons, physicians and nurses to come onto school campuses or even children's homes or any public or private place for the purpose of administering vaccines, I want to be clear that **AT NO TIME DOES ANY PERSON, PHYSICIAN OR NURSE HAVE MY PERMISSION TO ADMINISTER ANY VACCINE TO MY MINOR CHILD FOR ANY PURPOSE**. Should the bodily integrity of my child be violated in this manner, I will not hesitate to pursue any and all legal remedies available to me under local, state, federal and international law, PERSONALLY, against the responsible parties to the maximum extent of the law.
