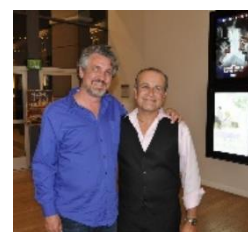


Dear Del, Cat, and Aaron,

I viewed the Feb 15, 2024 *The Highwire* episode, specifically showing Aaron's presentation in Arizona and ICAN's newest proposed bill, the **Vaccine Confidence Bill**. I want to share with you my honest opinion on your bill, but before that I would like to set a background on where I am coming from. I am sure that my correspondence with all three of you throughout the years and the work that I have done since I got involved in the vaccine debate back in 2015 when SB 277 was being proposed reflects how much you and your work mean to me and how much I appreciate it and my good intentions, and what it means to our movement, **Advocates Against Forced Vaccination** (AAFV). I am also sharing my views as a sponsor of your work, as noted in your show's intro.

I asked that you bear with me as I present my arguments, which may seem unrelated to your bill, but which I will tie back together once I get to your bill. We are in the same business: investigate, report, and take legal action; except that I created a Church to add a spiritual touch to our Freedom Fight, and wrote activist music to match, all in service to God. Del's work in *Vaxxed*, showing the CDC fraud behind MMR vax safety claims, followed by Polly's *Vaxxed 2* proof that the injuries are being caused by all vaccines, as well as Cat and the *Highwire* team reports was what created the foundation of our modern "public movement".



The Highwire became the primary source for us to speculate about how much our government and BigVaxPharma could be corrupt, but it was until Aaron did the Lori Matheson case deposition of Plotkin on 1/11/2018 and those videos being released on 10/8/2018, that our movement confirmed that both our health authorities and this evil industry know perfectly well of all the harm that the vaccines are causing in our children. I was so impressed with the content of Aaron's meticulously-extracted testimony from Plotkin, that I reviewed the 9 Plotkin videos, created a summary of all the things I identified in the video and transcripts, and even created a summary of the summary to make it easy for our Vax Truth followers to go through (see <https://thenaturallawchurch.com/wp-content/uploads/2022/12/plotkin-deposition-summary.pdf>; see <https://thenaturallawchurch.com/wp-content/uploads/2022/12/plotkin-deposition-summary-excerpts.pdf>).



Aaron, it was a brilliant idea, whoever it was, to upload the full Plotkin deposition on the YouTube "Lars P" channel on 10/4/2018 to make it impossible for our enemy to try to hide it by having the Cour seal the deposition and make it inaccessible. I see no other purpose for that channel, as it never posted anything before or after the 9 Plotkin videos. By the way, videos 7 and 8 have been banned under Youtube community guideline violation excuses, video 8 coincidentally being the one that discussed fetus tissue in vaccines. As a note, Plotkin has not changed his ways and justifies the COVID-19 vaccines, which he told me when I

called him about a year ago, his cell phone number appearing in one of my FOIA requests (see <https://thenaturallawchurch.com/wp-content/uploads/2022/12/stanley-plotkin-rb-phone-call-12-13-2022.pdf>).

Once I started in this movement in 2015, I immediately started doing FOIA requests, knowing that this was a good strategy to see the actual thoughts/actions behind our politicians and government workers, and I had never heard of Plotkin until the Siri deposition, but I had done FOIAs on Dorit Reiss, so I decided to FOIA Dorit through her University and I shared the emails released in Sayer Yi's Basecamp Group, *Alliance for*



*Vaccine Awareness*, which is when on 1/15/2019 Cat reached out to me requesting the University's letter confirming the validity of the emails, which *The Highwire* exposed on Episode 94 on 1/17/19, together with the Plotkin exposé. Del, it was great when you announced around 2021 that you would be using FOIA as a tool to expose all the vax fraud, apparently starting in July 16, 2021, with your CA CDPH FOIA on COVID-19 vaccine breakthrough infections, and if in any way my work helped you to consider this FOIA strategy, I am proud and honored to have helped (to be honest, I never wanted to be directly involved in the AAFV movement, I have always tried to focus on providing info to others so they can run with the ball, for personal reasons. I am a one man show, and as Cat knows, I solely finance my work and my Church and don't take any donations; instead, I encourage those that offer them to donate to ICAN and others to finance our movement).

The reason I made the comments above was to note how much I admire the three of you and your team, blending your journalism with your legal activism, how grateful I am for what you do, and to show that in good faith I share my thought with you for the benefit of our movement. So, with that said, while I cannot say that I oppose your *Vaccine Confidence Bill*, because there is a good intention behind it, I do think that this is not the way to approach the situation we are in now, in the most urgent and dire sense of the word.

The Bill is a reflection of the statement that many like good-intentioned Bobby and Del often claim, that starts with, "*I am not against vaccines.*" I don't agree with such approach. We all know that all of the CDC recommended and state-required vaccines have not gone through proper studies, that they have not been proven to be effective, and that they are harmful, from the minimum nervous ticks it can cause, to sever autism and death, clearly admitted by the manufacturer's own vaccine box inserts (see <https://thenaturallawchurch.com/wp-content/uploads/2022/12/vaccines-insert-analysis.pdf>) and also unfortunately confirmed by the thousands of parents that regret and suffer the consequences of having trusted our health authorities and their doctors and voluntarily vaccinated their children, like the parents of the McDowell triplets, the best, undeniable proof that vaccines can cause serious injury (see [VAXXED STORIES: THE MCDOWELL TRIPLETS IN MICHIGAN \(PNEUMOCOCCAL\) \(bitchute.com\)](https://bitchute.com/vaxxed-stories-the-mcdowell-triplets-in-michigan-pneumococcal)). Not even Dorit can argue that; that is why she always deleted this video without comment from her Facebook page all the times I posted it to counter her vaccine safety claim posts.

Why do I mention this? Because this is a reflection of the power of government, the press; of peer pressure, of an attack on someone's reputation and legal intimidation tactics, and unfortunately, the majority of the population has been convinced that the vaccine program is beneficial, as opposed to potentially deadly. It is my personal belief that these types of statements, "*I am not against vaccines,*" are made to avoid public criticism because of such facts, that it can be used against us and can somehow discredit us and our work. It is not a matter of whether we vaccinated our children many years ago, like Bobby says, or not at all, as Del says; the fact is, today, none of us would ever recommend ANY vaccine to anyone, because the evidence is overwhelmingly pointing against vaccines.

But I understand why such statements are made; unfortunately, it is like saying, we believe vaccines could work and that combining peanut oil, DNA of specific body parts, like a fetus' tongue, chicken and meat products and other things, with aluminum and other neurotoxic substances, confusing the immune system about the former product's nonnegative attributes, attacking them, can be a good thing. In other words, we are falling in their and our own trap. It's like looking up at the sky and seeing obvious Toxic GeoEngineering/ChemTrails persistent lines and haze, and saying, "*maybe they are contrails*" (see my affidavit on chemtrails, at <http://tinyurl.com/RBeas-Affidavit-Chemtrails>). So let me address the latest ICAN proposed bill, which like your other proposed bills, from the *Medical exemption Bill*, to the *No Liability No Mandate Bill*, are intended in a nutshell to stop mandatory vaccination and give us a way to avoid it (see <https://icanlegislate.org/model-bills-page/>).

In Aaron's AZ Committee comments, he makes it clear that the intention of the text of the bill is to give us a secure opt-out way to avoid vaccines, but the text does not reflect that. As Aaron said in so many words, if the conditions of the bill are met by health authorities, then the government is justified in making and imposing vaccine mandates. This type of approach is similar to what I describe above, being "careful" not to upset the mainstream hypnotic mass belief that vaccines are safe.

Aaron mentioned that the proposed bill "*assures the public that an exemption exists for required vaccines that do not meet certain minimal requirements.*" This implies that in some cases no exemption exists. We have to remember that in law, it is not only what the text of legislation, laws, administrative agency decisions or court decisions say, but what they mean. Vaccine effectiveness and safety is nothing more than dogma, like Aaron said.

This brings me to why I brought up the issue of us using FOIA. The studies that ICAN has reviewed and share with its audience, together with what it has uncovered under FOIA requests, confirms not only the health authorities' lies about safe and effective vaccines, it more specifically shows that those behind the vaccine program, from the government agency level to Big Pharma and the Cabal behind it, that if this is allowed to happen, it can only be for the purpose of knowingly harming us.

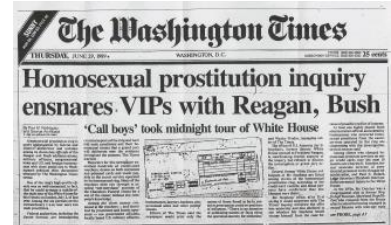

All these demon-inspired events are blatant, without fear of being criticized, showing just how powerful our enemy is. In fact, after the last Super Bowl, pRESIDENT Biden did a tweet with a satanic-like picture of himself, and he wrote, “Just Like We Drew It Up,” which I see as a reference to the half-time satanic ritual, “Drew It” being code for a *Druid* ritual, all related to the Illuminati and the promoted New World Order/Globalism. We can no longer justify those like Plotkin and Offit as having good intentions. They simply fall in one of two categories, both including that they know perfectly well that harm and death are a result of their statements and actions: (1) Those that simply do it for profit, and (2) those that do it for profit and to do harm, as described above, part of the global New World Order/United Nations/WHO/WEF depopulation agenda. Even the scientist that appear on *The Highwire* in this week’s show, who created a virus-based vaccine, when he was emotional and cried, it could be that he thinks it will help humanity, but his emotion was probably more because after 20 years of research he finally was successful, and he knows he will now probably make millions with the patent. That new patent owner most likely knows more about viruses than we do. Do you think that he does not know what can go terribly wrong with his invention? I doubt it. Just like Oppenheimer and the atomic bomb, wishing for the best, but not stopping until it may be too late. The power of fame and fortune – Just like Satan likes it!

I also disagree with the general statement made by some that whether to vaccinate or not, or to get an exemption, is a decision that has to be made between the patient and his/her doctor. THE DECISION HAS TO BE MADE EXCLUSIVELY BY THE INDIVIDUAL THAT MAY BE REQUIRED TO TAKE THE SHOT OR FOR THOSE UNDER THEIR CARE. To take or not the vaccine should be considered as nothing more than a doctor’s recommendation for us to consider. As to written exemptions, medical or otherwise, we should not be limited to our doctor’s decision and religious rights, as I will discuss below.

We no longer can make proud statements that the USA has the best medical system in the world, not after the Covid *Plandemic* showed us how corrupt the medical system is, doctors included. Think of this: Do you think that the Pfizer et al scientists did not know the harm that their vaccines would cause? Of course they did; they probably know it much better than we do (see [PFIZER SCIENTIST ADMITS COVID-19 INJECTION CAUSES MYOCARDITIS \(bitchute.com\)](https://www.bitchute.com/video/dnM5GNCxzuCC/)); see also [PFIZER SCIENTISTS ADMIT NATURAL IMMUNITY BETTER THAN COVID-19 VACCINES \(bitchute.com\)](https://www.bitchute.com/video/dnM5GNCxzuCC/))

In fact, I believe that the Vax industry does many unpublished/secret studies on their future proposed vaccines before they submit their application, which would explain how they decide for how long to do and record the published studies, to minimize exposing their long-term vaccines’ dangers. This would explain how in the Siri deposition, Plotkin admitted that he was involved in one study using 76 fetuses, admitted that there had been many other studies by others using healthy fetuses, but when asked about how many fetuses his personal studies had involved, he said that not many more.

At the end of the day, this purposeful destruction of the health of the Children of God is very clear to all of us, but whether we admit it or not, we tend to be careful to avoid the Government's wrath when we expose it. This is clear to me when Del in his shows expresses his outrage about the lies behind vaccines, but then makes disclaimers to try to minimize the potential of legal retribution/lawsuits by our corrupt *de jure* or *de facto* government system, bought and "*paid for by Pfizer et al.*" The sooner we admit vaccines and those promoting it, knowingly or unknowingly, have a Eugenics end to their goals, the sooner we can be faithful to our eyes, our reasoning, and our belief that we are in a war for the survival of all Men and Women in our planet. The reason I brought all this up, is because your Vaccine Confidence Bill is written under the Enemy's terms. Simply the title, "*An act to increase vaccine confidence*" promotes vaccines, all of which we know have not been properly tested and which cause serious injuries more frequently than acknowledged by BigVaxPharma, our health authorities, and Fake (thank you, President Trump) Mainstream Media. As I mentioned above, all your vaccine bills seem to have the same goal, to give us a way to get out of mandatory vaccination, which this bill does not reflect. They have us playing their fraudulent game. Because of this, the bill's title should reflect specifically what we are aiming for, regardless of whether politicians like it or not. We do not want to give them any leeway to modify it in the future, like Barbara Loe Fisher explained on the Highwire recently that they did to the 1986 Act, so the name itself should make it clear that the whole purpose is to stop mandatory vaccination – totally! A title like:

- The Right to Refuse Vaccination Bill
- No More Mandatory Vaccination Bill
- The Freedom to Decline Vaccination Bill
- The Vaccine Freedom Bill, or
- **THE RIGHT TO SAY NO TO VACCINATION BILL**

While some of you may think that congressmen are not ready to have such a bold bill against mandatory vaccination, many of them have opened their eyes thanks to the *Plandemic* policies, and your activism; and even more enticing, all of them now know that the majority of the people now see the covid fraud, and they can easily see how that same fraud can permeate to all other mandatory vaccines.

In his presentation, Aaron made it clear that under the bill, if the government meets the 4 requirements listed, that then they can mandate the vaccines, so let me break down the Bill based on how I interpret it.

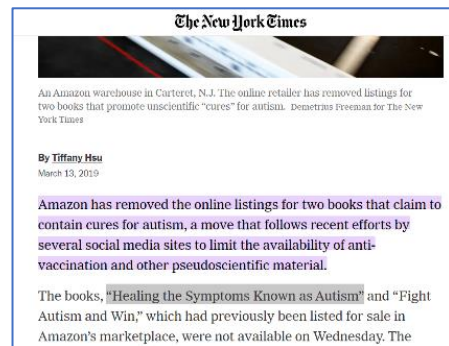
The Bill clearly notes that the government can mandate vaccines as long as they accomplish certain things:

***"Assures the public that an exemption exists for required vaccines that do not meet certain minimal requirements."***

This is what the bill says, but what it implies and means is: There is NO exemption if minimum requirements are met. While this is good intentioned, it helps nothing when we live in a corrupt

system like the one we presently have, now fully exposed by how they managed the whole *Plandemic* and the unjustified lockdowns and masking. Here is a simple example: When Del showed a graph showing that when Trump first mentioned Hydroxychloroquine, there had only been about 36 alleged covid deaths, shortly thereafter fraudulent published studies came out that the CDC/FDA used to have it banned, and even after being retracted (like the one in the Lancet, with the porn guy), they continued to use it to attack HCQ, like they did with Ivermectin – and because these are life-saving drugs, **Fauci et al COMMITTED MURDER.**

The same happened with Jim Humble and MMS/Chlorine Dioxide, they were attacked and discredited, together with Kerri Rivera's book on MMS and autism, which *The Highwire* purposely did not cover, when on Episode 102 Del talked about Amazon censoring two books around March 12, 2019, pointing among others, to a *New York Times* article, stating that Amazon had banned two books addressing safe unorthodox cures for autism, but Del only mentioned one, "*Fight Autism and Win*", and did not mention Kerri or her book, "*Healing the Symptoms Known as Autism*," maybe for fear of legal and media backlash, because the FDA was calling Kerri's treatment a chlorine-based toxic solvent (their own study proving otherwise; see <https://thenaturallawchurch.com/wp-content/uploads/2022/12/fda-warning-on-mms-and-supplier-rebuttle.pdf>). **This is what happens when we allow ourselves to play in the enemy's field, not on a leveled playing field.** See my study on MMS, at <https://tinyurl.com/MMS-Study-RBeas>. Your latest shows on ChemTrails and other so-called conspiracies shows how much you have expanded, what you tell us, to "**Be Brave!**" We are fighting a **New World Order Octopus** that has 100 tentacles, touching all aspects of our lives. We cannot just fight against 1 or 99 of them, we must expose and destroy all 100 tentacles so that power can be taken away and true freedom overcome. Amen.



James Lyons-Weiler also just came out with two articles, one is a study by Albert Benavides showing how the CDC manipulates VAERS, noting that "**the CDC/FDA uses VAERS to run cover for Big Pharma.**" The other article is about a study of 99 million persons that claims in the headline that the COVID-19 vaccines injuries are rare, when in fact it shows otherwise, manipulating the data to try to come to that conclusion, which Del covered in this week's *The Highwire*.

The bill's justification phrase promotes vaccines, contrary to the fact that we know that there is no safe vaccine!

The phrase "*Limited informed consent exemption*" say that the government can decide when an exemption can be authorized. Isn't that what we saw with the military and other institutions, including Biden's vax mandate for companies with 100 or more emps?

**“A” is trusting the government to do the right thing, but they will never admit they don’t meet the minimal standards. Just ask ACIP.**

A. To increase public confidence in immunizations, the department shall publicize that an exemption exists for required vaccines that do not meet the minimal standards provided in this part.

B. Notwithstanding any other law, a person who is required to receive an immunization for any purpose may claim an exemption from the immunization requirement if there is not a vaccine approved by the FDA to fulfill the requirement that meets the following criteria:

1. The clinical trial the FDA relied upon to approve the vaccine evaluated its safety for at least one year after it was administered against a control group that only received either (a) a placebo or (b) another vaccine licensed as provided in this paragraph.

**How about long-term effects beyond one year? Didn’t Gates say we would know the damage of the CV vaccines in 2 years? Also, why would we ever say that there is an exemption from using a true saline placebo? This is probably the thing that I like least from this bill. We must insist on true placebos, no questions, never allow them to pull a fast one as before. BigVaxPharma in its studies/inserts may admit to some injuries or not, but in the future they might not, if protected by laws like the one now in France that Del just reported on.**

2. The department posts on its website the injuries or diseases caused by the vaccine and the rate at which the injury or disease occurs from the vaccine.

**This is something that they are already supposed to do, they even say it in the CDC website. And what do we get? Manipulated data and the Vaccine Safety Datalink database moved to a private entity to avoid FOIA exposure (if we can’t get it from them [Kaiser?], maybe we can force the CDC to get it back via legal action, and then we can access it via FOIA).**

3. The risk of permanent disability or death from the vaccine has been proven to be less than that caused by the infection it is intended to prevent.

**Even though it looks OK, I disagree with this statement, too. If the disease and the vaccine can cause the same injury, should we not have the right to decide where we prefer to get the disease from? From Pharma or God? The Lord is our Savior.**

4. The vaccine's manufacturer has liability for the deaths or serious injuries, if any, caused by the vaccine.

**This of course I like and approve, just like I prayed for it in the L.A. Defeat the Mandates event. I would just add, that if this were to become a federal bill, it should request the dissolution of the vaccine court, as it would be no longer needed. Something to consider would be whether to make lawsuits retroactive to some extent, considering the purposeful profit above injury, fraudulent actions by BigVaxPharma, and a Crime Against Humanity.**



C. The public shall be informed that a person may claim the exemption in subsection b on the person's own behalf or on behalf of the person's child or dependent, and that the department or any other state agency, board or commission may not require the person to meet any other condition or requirement to claim the exemption.

D. As used in this section the term "FDA" shall mean the united states food and drug administration and the term "any purpose" shall include as a condition of employment, school attendance, license, certification or degree.

If we don't follow my proposed approach, to be firm in our right to opt out of vaccination, we will be like the vax activists in California, who allowed themselves to be convinced by others not to appeal SB 276 and SB 714 (extremely limited medical exemptions, and liability to doctors giving them), and then wanted to get a bill passed to reverse only one of the things taken away by these bills. I spoke to the attorney who wrote the proposed bill, that ultimately went nowhere, and he confirmed that his plan was to defeat these bills, but long-term, doing one bill with one issue at a time. To me, it seems like a losing strategy for the AAFV community, but profitable for the involved lobbyist and attorneys. Your bill is like asking the government for honest elections, but avoiding addressing the 2020 stolen Trump presidency, which gives rise to future fraudulent elections. We have not time to waste!

So, in the spirit that we must have a bill that truly protect us from mandatory vaccination, the following text or something similar is what I would recommend that your efforts be focused on. Some things mentioned therein will be discussed below, as strategies for defeating existing laws that removed the personal or religious exemptions, like SB 277, which ICAN is preparing to do.

**TITLE: The Right To Say No To Vaccination Bill**

**PURPOSE:** Assures the public that any person on their own behalf or on behalf of the person's child or dependent will always have the legal right to a vaccine exemption, to any vaccines or similar medical interventions, past, present and future, based on personal, medical, philosophical and/or religious beliefs.

**JUSTIFICATION:** Adding such unlimited rights to chose whether to vaccinate or not will remind both the government and the people of this great Republic that our rights come from God, that this is confirmed in the U.S. Declaration of Independence, and that it is reflected in the U.S. Constitution, in the 1<sup>st</sup>, 4<sup>th</sup> and 9<sup>th</sup> Amendments, all in accordance with the Common Law (*optional*) and the ultimate Law of the Land, ***The Holy Bible, God's Word.***

(RB Note: As to the above statement about the Holy Bible, if used, all as proclaimed by the Catholic Church, who through **Papa Bulls** authorized European nations to conquer America, and set up all corporations to run such operations. Being the *Parent Company*, the Catholic Church is the highest authority over all these nations and their governments, their corporations, and the *de jure* and *de facto* entities that grew around them. In other words, in the Western World, at a minimum, ***The Buck Stops at the Vatican Steps!*** See the ***Unam Sanctam*** 1302 Papa Bull and my first published Sermon, which I just saw Youtube removed, but which I just uploaded to

### TEXT: Elimination of All Vaccines Mandates

A. Vaccine mandates have been in place for many decades in the United State, going back to the early 1900s. In those days, like today, the manufacturers of all existing vaccines failed to disclose all the potential minor, serious and deadly harm that could be caused by their products, as was well documented by the 1920 book by Chas. M. Higgins, *"Horrors of Vaccination Exposed and illustrated,"* and other similar writings of the time. Read Higgins' book, at <https://www.gutenberg.org/cache/epub/69965/pg69965-images.html>.

B. With the advent of the public's right to Freedom of Information Act requests, combined with the advent of the internet, where research can be easily done to get data from all over the world, regarding fraudulent and harmful pharmaceutical industry practices, as well as data linking vaccines to serious injuries and fatalities, we can now uncover the truth about vaccine harm, as has been uncovered by the research and news reporting done by news organizations like the *Informed Consent Network*, through their weekly investigative reporting on their internet program, *"The Highwire"*, since April 13, 2017.

C. The 1<sup>st</sup> Amendment to the U.S. Constitution clearly states that the people have a right to practice their religious beliefs in the way they see fit, and that the government will not be involved in *"prohibiting the free exercise thereof,"* which includes refusing vaccination because it is against their religious principles, beliefs and practices.

D. The 4<sup>th</sup> Amendment to the U.S. Constitution states that we have a right to be *"secure"* of our person, our body, the word secure encompassing to be safe and free of harm, and not exposed to danger, and that we have a right to reject things that are repugnant to our moral and spiritual beliefs, not allowing us to have our bodies' seized by any government agent in order to participate in such unsecure and potentially harmful interactions.

E. The 9<sup>th</sup> Amendment to the U.S. Constitution states that *"the enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people."*

F. The U.S. Declaration of Independence makes it clear that our rights come from and where lovingly given to us, in the form of **Free Will**, by God, who allows us to live our lives as we please, so long as we do not intrude on other's rights, as reflected in the Common Law.

G. This **Free Will** given to us by God, and which must be respected by all levels of government, as reflected by the Declaration of Independence and the 1<sup>st</sup>, 4<sup>th</sup> and 9<sup>th</sup> Amendments to the Constitution, as outlined above, confirm that we also have a personal and philosophical God-given right to refuse vaccination based on such rights, regardless of whether a person believes in God or not, God being the creator of all things, and God granting this right to all His Children.

H. The public shall be informed, and the government will respect and abide by the fact, that a person may claim a vaccine exemption to any and all existing and future vaccines, for personal, philosophical and religious reasons on the person's own behalf or on behalf of the person's child or dependent, under all circumstances, and that the department or any other state

agency, board or commission may not require the person to meet any condition or requirement to claim and be granted a vaccine exemption.

I. The Right To Say No To Vaccination shall include and extend to any verbal or written declination or refusal to vaccination for any purpose, including but not limited to any condition of employment, school attendance, license, certification or degree, visiting any public or private place, participating in any social or community activity, visiting any entertainment venue, visiting any restaurant, getting care in any medical establishment, traveling for any purpose without the need of a vaccine passport inside or outside of the United States, any right to purchase in person or online any tangible or intangible items, access the internet, or receive any other public or government provided services.

Ever since AB 2109 was proposed in CA by Richard Pan I understood clearly that the religious exemption was our ultimate defense against forced vaccination, because this specific right was clearly outlined in the 1<sup>st</sup> amendment. With what has happened with SB 277 and 276 and similar laws in a few states, but planned for all, we need to expand beyond the 1<sup>st</sup> Amendment and how we have used it.

In all or most post-2015 lawsuits against the mandates, the religious exemption is typically linked to the aborted fetus argument. This fails to account that when we say that we are the Temple of God and that we will not harm our body, as expressed in 1 Corinthians 3:16 and 6:19, and more specifically in the warning in 1 Corinthians 3:17, *"If any man defile the temple of God, him shall God destroy; for the temple of God is holy, which temple ye are,"* it includes not using vaccines we know are not safe and cause verifiable harm. As used therein, "defile" also encompasses purposefully harming our body, the temple of God, which now we know vaccines do, whether it is noticeable or not, all affecting our ability to serve and worship God. Thus, simply the harm potentially caused by vaccines is a valid religious reason to avoid vaccination, something I have not seen directly and specifically expressed in court filings.

We must cover all bases and begin to use the 9<sup>th</sup> Amendment in our defense, as it is clear and directly related to our God-given rights. I believe the link to our right not to vaccinate under this amendment can be easily expressed:

1. The 9<sup>th</sup> Amendment reads, *"the enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people."* What is the U.S. Constitution? Without getting into the issue of whether our present federal and state governments are *de jure* or *de facto*, commercial/admiralty fictitious entities we call corporations, like Anna Von Ritz says, the U.S. Constitution represents a services corporation contract/compact that provides 17 services, including providing courts, etc., and nowhere in such constitution is there any service described that states that the government has either an obligation to keep us healthy, or that it can force us to be healthy using any mandatory procedures. **The "Rights Retained by the People" are those rights given to us by God, as expressed in the Declaration of Independence, which encompass our right to act based on our personal and philosophical beliefs. The 9<sup>th</sup> Amendment does not refer to any government-created privilege.**

This echoes the words of our beloved former U.S. representative Ron Paul, that at the time of his presidential run (sabotaged by the Cabal, using MSM news-fabricated fake exit polls to discourage people from voting for him, saying he lost first, and then weeks later in a little hidden note saying he actually won) told us, that all these federal agencies were not constitutionally supported, established or mandated, and therefore are in fact repugnant to the Constitution.

2. God gives us free will to show good or bad in our lives. This is well explained in Wikipedia under *Free Will*:

*"... (3) Acquired freedom is freedom "to live as [one] ought to live," a freedom that requires a transformation whereby a person acquires a righteous, holy, healthy, etc. "state of mind or character."*

*The Bible testifies to the need for acquired freedom because no one "is free for obedience and faith till he is freed from sin's dominion." People possess natural freedom, but their "voluntary choices" serve sin until they acquire freedom from "sin's dominion." The New Bible Dictionary denotes this acquired freedom for "obedience and faith" as "free will" in a theological sense.*

*Therefore, in biblical thinking, an acquired freedom from being "enslaved to sin" is needed "to live up to Jesus' commandments to love God and love neighbor."*

*Jesus told his hearers that they needed to be made "free indeed" (John 8:36). "Free indeed" means "truly free" or "really free," as it is in some translations. Being made "free indeed" means freedom from "bondage to sin." This acquired freedom is "freedom to serve the Lord." Being "free indeed" (i.e., true freedom) comes by "God's changing our nature" to free us from being "slaves to sin." and endowing us with "the freedom to choose to be righteous."*

Here are two Biblical passages addressing Free Will:

*"The Lord is not slow in keeping his promise, as some understand slowness. Instead he is patient with you, not wanting anyone to perish, but everyone to come to repentance." 2 Peter 3:9.*

*"You, my brothers and sisters, were called to be free. But do not use your freedom to indulge the flesh; rather, serve one another humbly in love." Galatians 5:13.*

We should also consider if the 4<sup>th</sup> Amendment can also be used to argue the right to decline vaccination. The 4<sup>th</sup> Amendment reads in part: *"The right of the people to be **secure** in their persons, houses, papers, and effects, against unreasonable searches and **seizures**, shall not be violated."*

In this respect, we must see ourselves not as physical earthly bodies, but as Children of God. In Jeremiah 1:5, our Lord says, *"Before I formed you in the womb I knew you."* Even though this is in reference to Jeremiah, this also implies that we too existed before our present earthly birth. Therefore, ***each Child of God is simply an Etheric Individual Spiritual Conscience with a Soul*** that connects it to a human body to express our love for God, noting that ***"we are but a drop in***

***the Ocean that we call God.***” Thus we have a God-given right to have our bodies secure, including from injury, and if we do not want to be vaccinated and the government forcefully does it against our will, whether pinning us down on a table in a *Virus X* quarantine camp, or destroying our employment income as a way to earn a living, like it happened with the *Plandemic* lockdowns, forcing us or threatening us to be vaccinated, that can be considered a seizure or an attempt to a seizure of our person, or so I believe it can be additionally argued.
