



JIM HUMBLE'S LAST ATTEMPT TO SAVE THE WORLD

In the world of medical alternatives probably no treatment has saved more lives and cured more diseases than Chlorine Dioxide (CD), used by oral ingestion, and being so inexpensive that a person can cure himself of a serious COVID-19-like disease and symptoms or malaria in a few days with reduced discomfort and for less than a dollar. This is the primary reason why CD has been attacked and demonized so much by our health authorities and the media.

The person that introduced Chlorine Dioxide as a medical cure to the world was Jim Humble, back in the late 1990s. I did a study on Jim's life, his innovation known as MMS, which creates Chlorine Dioxide, and how all the related protocols developed to use this miraculous substance (originally Jim named the substance **Miracle Mineral Supplement**, later renamed due to attacks on him and MMS). I was one of the fortunate persons that have met Jim in person, and my life is better because of it, in multiple respects, which I will share herein. Jim passed away on September 1, 2023. Andreas Kalcker, who helped perfect the MMS protocol and came out with the alternative substance he called Chlorine Dioxide Solution (CDS) made a farewell tribute to Jim, which is worth watching, at <https://tinyurl.com/Kalcker-Tribute-To-Jim-Humble>.

Now that Jim has passed away, I feel that it is time to reveal one more story about Jim and how he was willing to do anything to bring to the attention of the world the incredible benefits of Chlorine Dioxide. This is my story of Jim's attempt to save the world from disease, our corrupt government and the media's attempt to suppress it, and once and for all destroy Big Pharma.

I first heard of MMS around 2004 from a friend. I have always been a believer in natural cures and have studied successful remedies that have been attacked by our health authorities. The results that Jim had and continued to obtain with MMS were piling up, proving its effectiveness. I used it successfully without an issue and even took high doses at some times to ensure that there were no serious side effects before I introduced it to my followers. Then I had a musical project called Café Peyote, and aside from my music and music videos (see <https://thenaturallawchurch.com/music-videos/>), I was also addressing many other health issues, including forced vaccination. Around that time, I emailed Jim to get recommendations to treat a certain condition that a family member had and also letting him know about my webpage. He provided recommendations for the treatment.

On July 2, 2017 I submitted to President Trump, the U.S. Department of Justice, the U.S. Department of Health and Human Services, and the U.S. Department of Education, my *Vaccine Class Action Complaint*, where I exposed the complete fraud being perpetrated upon families

whose school children were forced to get vaccinated in order to attend school, from the vaccine manufactures, to our health authorities, hospitals, individual doctors, and individual schools. I also told Jim that I had started a church to help people get religious exemptions to vaccination and noted how I had used the foundation of his church, *The Genesis II Church of Health & Healing*, to create mine, which I named *The Natural Law Church of Health and Healing*. He responded:

"I am very excited about what you are doing. I appreciate your work immensely and I want to see it continue forward. Keep up the good work."

On July 16, 2017, I emailed Jim again giving him more details as to my religious background and he replied as follows:

"I am an inventor. Not only in many things including inventions in spiritual things. I have come up with an idea that is secret. So secret I cannot disclose it to anyone yet. But remember, the 60 doctors killed in the last year for working on medicine that actually works. I hope you understand that we work in a dangerous area, but there may be something that we can do about it. But I want you to know again that when we get into this we can change the world, but then we could be shot as well. There is only one thing we must do to create the biggest change ever made. This is the time to back out. I would never stop you from backing out, but the bad guys would. Let me know what you think."

The following is a copy of our email communications via Proton Mail that Jim and I had for the next six months prior to me going to see him in the state of Jalisco in Mexico. I corrected some typos and combined and excluded emails as necessary:

Jim:

Somehow, I knew that you were one that I was looking for I will be checking with Daniel's father. I have a plan, but I cannot tell you over the internet even on proton mail. I just don't trust it that much. I have to get the information to you. Maybe you can come visit. I also need to get the plan to one other person in Europe at this time. It might take two more people or maybe one more to make a total of 4. Trust me. I have a plan that will change earth using MMS. It will only take weeks or a few months to begin the big change. Trump is a good indication at this time, but we cannot rely on him right now. We must disconnect America and then Earth from the medical / pharmaceutical cartel. If we don't no matter how good things get, the medical / pharmaceutical cartel will draw us right back into the mess. That is their one final big monopoly that they think will always save them no matter what comes. Without stopping the Medical / pharmaceutical cartel we nor no one else can save Earth.

So, once you get the plan, then we can discuss things without disclosing the plan or what we really know. We have to be careful.

We will have to wait until I have book sales going again as we need the money for expenses. So that will slow things up a bit but planning can continue.

Ricardo:

OK. Two things:

1. More or less where are you living, so I can see the logistics for going to see you. You can even tell me simply how many driving hours from Tijuana (I assume you are still in Mexico, maybe Jalisco). Again, I live in San Diego County.

2. I will be having open heart surgery probably within the next 2-3 weeks and I will not be able to travel for 6-8 weeks so that coincides with the delay you anticipate. Once you speak with Larry please just confirm if you will want me involved.

I remember you wrote a book on spirituality, but I don't remember the title and I did not find it in the Church book section or Amazon. What is the name of the book and where can I get it. Might as well enjoy it while on recovery.

Jim:

I live about 20 minutes out of Guadalajara, of course in Jalisco.

I worry about open heart surgery. Most all cases can be solved with MMS protocols. I have been involved in hundreds of open-heart surgery, most in the fact I advised against it. Many lost their lives. You should give MMS a real chance as it has solved thousands of cases that would have needed open heart surgery. Of course I don't know your story at this time, but I know that the majority of the surgery, like 95% is unnecessary maybe even more. The only area in the body where cholesterol is formed in arteries and veins is the arteries and veins right on the heart. The body deposits the cholesterol there to prevent the artery or vein from collapsing each time the heart beats. All the other veins and arteries they claim have deposits in them is bull shit. MMS clears out the cholesterol in record time. There is a reason for the deposits. The body needs vitamin C and several amino acids for the walls of the vessels, however, when you clean out the cholesterol the body strengthens the walls even if you don't take the amino acids. It is better if you do. I have the names of the amino acids, but not at my fingertips today. Let me know what you think. You are risking your life any time you allow medical operations, but I admit some rare times it is necessary.

Ricardo:

I have congenital aortic stenosis, I was born with a defective aortic valve, of the three leaflets that open and shut two of them seem to be stuck together. I was told since I was a child that I would need an operation at around 35 to replace the valve (every time I did exercise I got exhausted soon, so my physical activity was always limited). I never had to take any medication. I'm 60 now. I got a very strong flu about 4 months ago that not even MMS made a difference (RB Note: I did ultimately cure myself with MMS and vitamin supplements, but the symptoms were very strong and it took at least 3 times as long to recuperate, except for the heart issue). A couple of other things got complicated then and I had a very hard time recuperating, which took me about a month, then I started getting better, but in the last three week I started having chest pains, palpitation and I can tell the heart is malfunctioning, a weird feeling of emptiness, difficult to describe.

About 20 years ago the valved started no closing completely so I had blood going back in, which resulted in the heart growing, and now the echo supposedly showed that the aorta itself expanded and might also have to be replaced. After I do a CT scan this week the doctors will determine if only the valve will be change or if also the aorta, and whether the replacement will be a pig/cow valve or a mechanical one.

As to blockage and cholesterol, I have always maintained a level like a 15-year-old, excellent shape, and I attribute that to eggs. I love them and as a kid I would eat up to 4-6 a day, 6-5 days a week and I still eat them several days a week.

I think that the surgery in my case is the only solution, even though I tried to avoid it for so many years, but I am counting on God's protection for it to be a successful surgery. I am attaching my echo for your review. I appreciate your advice.

Jim:

I think it would be worth giving it a 2-week MMS try to see if there is an improvement. I have added a download of my latest book. It is a real fantastic book that took us 3.5 years 7 days a weeknight and day to produce. Look at the Starting Procedure, and protocol 1000. That is what you need. Be sure to read all of the rules. Don't miss the golden rules.

I need to talk to Cari about your staying here for a day or two before I can say one way or the other. I want her to be informed.

Let me know what you think. I'll get the Amino acid names tomorrow. Did you get the book from regular email?

Jim:

The three nutrients that are found in the walls of the veins and vessels running across the heart and most others are vitamin C, Amino acids L-Lysine, and L-Proline. Sorry, but you must find the manufacturer, but any good health food store that sells a shelf of amino acids will have them. Just take about twice what they recommend and you will probably get enough.

Ricardo:

One more thing. While you say vitamin C can be good for my heart, I would assume you also mean that I should take it after I finish my protocol to avoid MMS neutralization, correct?

Jim:

Yes, that is correct. Take C and the amino acids at least one hour after the last MMS dose for the day and preferably 2 hours after the last dose.

Ricardo:

Good morning, Jim,

I just spoke with Mark, the newsletter on my complaint will be going out today, my interview tomorrow for Sunday's show.

He explained your Church is unable to sell your books at this time due to being shut down by Paypal and others. I want to do some fundraiser for that children's project you mentioned to me.

How much do you figure you need, and how could I send you the funds if I am successful in my collection.

As to visiting you in 3-6 weeks, I will get a hotel room in your area and also stay with relatives. I forgot you are only 30 min away from Guadalajara. As to transportation, it's going to be better if I just rent a car at the airport so I can visit you and family as well.

As to my CT scan, it was planned for this Friday. I have moved it out two weeks so that it will be done after 2 weeks of MMS treatment. Once that is done, I will see the results with the doctors; if they say there is an improvement and/or if I feel better, I will postpone my operation indefinitely. If they say I'm still in bad shape and need the operation, I will go get a second opinion by getting a second echo and have the new doctors evaluate that and the CT scan. RICARDO'S NOTE: I followed Jim's advise and started taking MMS, 3 activated drops eight times a day, as well as 2,000 mg of vitamin C crystals, 1,000 mg of L-Lysine, and 1,000 mg of L-Proline once a day. As noted above, at that time and prior to starting this treatment I had a very strong flu-like episode that lasted for several day. My heart was very erratic, having palpitations, fast heartbeat, heart skipping some beats, feeling extremely tired, and a sensation in the heart of it being weak. I went to see the cardiologist weeks later and after they did my ultrasound he recommended I immediately undergo open heart surgery, for which I started preparing prior to my exchange with Jim. Ricardo:
Amigo,

My health has improved significantly in these few days, basically no palpitations and discomforts as had been the case for more than a month. I can only imagine/pray how good it will be after two weeks of cleansing with God's sacraments. Thank you for the information you provided.

At this point, if things go well as they appear, I might be visiting you in 2-4 weeks.

Jim:
OK, that is good.

Yes, the visit would be OK. I think we can come to an understanding. The money required would be (1) travel money into the US. (2) expense money to stay in an area for one or two weeks. (3) we may need another person we can completely trust for the same thing. I don't mind using my money but I have been shut down from selling my books for so long that I have no money at this time. I expect to begin sales of books in a week or two and will soon have money. but it will be a month or two. If we could get a donation that would be nice but it must not be a special donation. Just standard help. We cannot say it is for a special cause.

Ricardo:

Ok, let's see how I feel in a week or two and I'll be in touch as to visiting you.

I assume you are feeling better and that is great. Maybe that time you mention will be OK to come, but let me check with Cari. There is one other thought. I have one other person that might want to come and it would be best for us all to talk together. Let me see if I can work that out.

Jim:

OK. Sorry, been trying to set this up. Hope it doesn't conflict with your schedule too much. I'll let you know and if I cannot get it set, then hopefully you can come and our other person will just have to come later.

I was able to send off a letter finally to the gal that might or might not help you on a very important mission. We will see how it goes. Give me a day or so to get an answer and we will see if we can all meet to discuss the mission.

Ricardo:

Buenos días amigo,

I've been taking MMS for about 40 days now, together with vitamin C and the 2 amino acids. All my symptoms are basically gone.

I was thinking of stopping MMS after today, but to continue with the C and acids until I run out, maybe a week or two. Any suggestions?

Also, any idea on any future meeting?

Have a great and safe weekend.

Jim:

Glad you did so good. Vitamin C kills MMS. You must take them at separate times. Six drops of MMS daily is a maintenance dose and one should never stop MMS as the poisons abound in this civilization. MMS kills most of the poisons you might get daily including the bad stuff from the Chemtrails.

I will be writing to you right away. Feel like traveling? Do you live near or far?

Ricardo:

Yes, I always took the vitamin C 2-3 hours after each daily treatment. I will stop the protocol and will continue with the daily dose as you suggested, as possible. And you hit it right in the nail, we are showered here constantly with chemtrails, no more blue skies, only white hazy ones.

Yes, I'm ready to travel and can do it this Th-Fr, I'm in San Diego, CA.

Jim:

So sorry about that. I have a dozen things going and being an old guy my memory slips from time to time. I really want to talk to you but still need to work out the actual facts. Will get back to you as soon as possible. I really am sorry about this. Hope you are not upset.

Ricardo:

As a note, even though what we are trying to accomplish is important and urgent, please take your time. I'll be there.

RICARDO NOTE: At this point Jim's assistant/companion, Cari Lloyd, got involved in the communications.

Cari:

I apologize for not getting back to you sooner. Thank you for all the information in this note. Jim is not ready just yet for you to come visit -- but he is certainly interested in staying in touch, and we will let you know when things gel enough for you to come visit. Does this sound good? If you don't mind, can you send me your regular email address, and I will jot you a note there when Jim would like for you to be checking your protonmail, does that sound good?

Ricardo:

No problem Cari. Jim just sent me an email to the same effect and here is my response:

Thanks. No, no discouraged, on the contrary, excited. I just needed a more specific status like you said, 6 months. You had sent me an email that said "are you ready to travel?" so I thought that maybe I was confused somehow. So, take your time, amigo.

I just saw your newsletter on leaving the church. The idea of the church was a master stroke, a checkmate to protect our God-given rights. I congratulate you for having taken that course. As to the church management, Mark is a great guy and he will do perfect for the church, as he has the strength and valor and the passion to be in front of it, never give up, like you and me compadre.

Jim:

Ricardo,

Yes, of course I said that. And it still pretty much goes. There will just be only a very few of us. I chose you as you are not know to be associating with me and I was hoping to keep our association

confidential as much as possible. Things change as I go along. There was a possibility of receiving financing which would change the mode of operation some, but would be harder to keep things confident. And the master plan would not change much. But one never knows if help will come or not and I made the plan without the help. I however have decided I need to complete a project that is needed in the plan. So, it will be a while to complete the project. If I get some financing, I will be able to get the project done sooner, but I see it as a 6-month project at this time without the financing.

Hope I didn't discourage you.

Jim:

Well, I hate to see those guys attempting to push vaccination on America. That will result in a great deal of genocide. I must just go ahead with my plan and I see many bad things happening, but got to just continue ahead.

Getting ready to share my plan is hard to do. Only one other person besides my assistant knows the plan and he doesn't know it all. I only tell people as they need to know their part of the plan. Just trying to stay alive. We could discuss the plan a little, but can't tell it all.

Jim, Jan 6, 2018 (written by Cari):

Hello Ricardo,

Jim asked me to answer on his behalf. If you traveled to visit your relatives on the 16th, that would put you meeting us on the 17th, correct? That would work better for us, than the following week.

We agree meeting during the day is best. I will reserve Wednesday the 17th to see you, but please confirm at your earliest convenience that this in fact is what you are able to work out. Thanks.

RICARDO'S VISIT WITH JIM

As agreed, I travelled to the state of Jalisco and met with Jim and Cari around midday at a coffee shop, then we went to a restaurant and sat in a very private area and spoke for several hours. Jim did most of the talking sharing all his knowledge. We talked about Mark and the church, Andreas and CDS, and Karri and her work with autistic children. I spoke about me, my church, and my vaccine work, and how I wanted to help and put myself at his service. Jim also spoke briefly about his previous lives, how he had been in this fight before. Cari pretty much just listened. Jim and I identified perfectly as to our dedication to bring health to the Children of God and our eagerness and urgent need to put the plan in place. Also, we both had been through personal spiritual experiences, so our faith in God and our work was unshakable. Then, at one point Jim said he was ready to tell me his plan, then he looked at Cari and asked her if it was OK for him to tell me, but to our surprise, Cari said no.

Jim then explained that he and Cari had agreed that, because of the life-threatening danger of this plan, that they would not share Jim's plan with anyone on a first visit/interview (they may have been interviewing multiple persons to determine the best candidate that both agreed on).



Obviously, this was a disappointment to me, but understood all that Jim had gone through and how they have twisted his words and work to talk negatively about MMS. After about an hour Jim went to the restroom and I discussed this with Cari, noting my good intentions and asked her if she was familiar with my work and when she said no, I showed her my webpage with all my activist work, hoping that maybe she would change her mind, but she did not. Once it started getting dark, unfamiliar with the area and about 2 hours from where I was staying, I decided to depart. We all said goodbye in good terms and supposedly with the plan to meet again in the near future to start working together on Jim's plan.

I was scheduled to fly back to San Diego, CA two days later. All night I had been thinking how we could possibly expedite Jim not only telling me his plan, but also me/us carrying it out as soon as possible. When I woke up, I decided to try again and see if we could meet again, so I called Jim and Cari answered and said he was not available. So, I told her I was willing to stay longer so we could meet again, especially if she had changed her mind about Jim telling me the plan (my life's motto is, "*there is no worse attempt than the one you don't make*"), but she said that we would have to meet in the future. Jim emailed me shortly thereafter:

Jim:

So sorry I couldn't tell you everything. Cari and I have agreed with one another that on those we have come see us we will not tell all on the first visit. We made that agreement with one another and really cannot break the deal. Of course, there are those who we already know for years where we already have the first visit and usually more. I did feel really bad as I would have liked to have laid it all out today and Cari would like to also but we have made that agreement just so we won't make a mistake. It is all going forward and the book is 95% finished. Also, so is the longevity book. We have both agreed you are a great guy and we can trust you. So sorry we have that agreement, but over the years we have learned to be careful. As I mentioned to you in our conversation there are 81 of those dead doctors now, but in case you haven't looked on the internet for dead scientists and inventors, there are several hundred of them over the last 100 years.

Ricardo (to Jim and Cari):

It was obvious where the hesitation was, but I understand, it happens ... OK, so let me be honest.

It was obvious to me that the hesitation to share more details came from Cari. Just like me, Jim already knew I was chosen for him and vice versa. But no problem, I understand the concern and it is justified.

The only purpose of my trip was to have Jim share his thoughts so I can decide if I want to be part of the new project. Yours was to interview me. Now that you have told me You know you can trust me and are ready to share, instead of me coming back and spending another \$500 for a second trip just to hear Jim's story, it would be easier for me to stay an extra day, with only one extra day car rental expense. I can go visit you again today and if I decide to join then I can still come back in the future for more planning.

So, tell me if you want to meet today and explain in detail. If so, give me the time and we will meet at Blacks. I need to know asap so my wife can do all of the arrangements this morning before she goes to work.

Cari:

Hi, I have been talking to Jim, sorry it has taken a while, but Jim was sleeping when you called -- these last months we have been real night people, working until the wee hours of the morning. But we have been talking about your proposal to stay and Jim said it seems there is evidently a misunderstanding --because he wanted to take this time to get a little better acquainted and you had talked about coming for this purpose -- to get to know each other a bit better. He says at this point in time there is a lot at risk, and he feels we need a little more time than a couple of hours of discussion. He said we believe in you but he just needs a little more time to consider the situation and how to go about things. You have the basic plan or gist of what Jim would like to do in getting information out in a big way, but this information is not quite ready and when he shares it with you the first time, he would prefer it is handed to you in written, not verbally discussed out loud, just taking precautions at this point in time. If traveling here is a problem for you, as we mentioned yesterday, he said, he can come closer to you for our next meeting.

Jim says he really appreciates you coming a whole lot (me too) he is sorry if there was any misunderstanding between you. He is working on the details as hard as he can every day. As soon as we are ready, hopefully we can communicate here a little bit more, but he does not want to discuss "details" here either. Jim says he does not really feel afraid, but just that he wants to be extremely careful.

From Cari: Ricardo, I just wanted to explain that I am typing this for Jim, he is sitting here basically dictating. I am sure you can understand sometimes he can answer people a lot quicker this way. I appreciate you understanding my position even if I sometimes come across as over cautious. :-) I did take some time last night to look over your website--very impressive. Of course, there is a lot to chew on there--so I can see I'll have to go back there, will have to slot some daily time I think to get through some of your articles and things. I will do that. Maybe I'll make a list of questions to ask you on our next meeting ha, ha.

I'll close this for now, stay well and safe and keep up the good work,

Ricardo:

Hi Cari, thank you for your thorough reply.

No problem, as I said, unless you have a reason to come to Tijuana, I will gladly come back when Jim is ready, but again, only to get details, not another interview, I think I've proven my trustworthiness. I hope you see my "History" documentary ("*History of the World: The Earth's*

RICARDO'S COMMENT:

Around May 28, 2019, Amazon banned Jim's newest book, "*MMS Health Recovery Guidebook*," so I emailed Jim to let him know. He responded:

Jim:

Nice to hear from you. Good things are coming.

Ricardo:

Well, we better hurry because doors are closing everywhere. I am at your service, awaiting orders. Thanks

Jim:

Ricardo,

Hold tight one more month then write me. Things will happen big.

Ricardo:

Got it. I'm excited by your words. I will call you at the end of June. Thanks.

Jim May 2019:

That's great. I think you will be happy with the program.

I never heard back from Jim or Cari, although I emailed him at least 6 times. Then COVID-19 hit a year later and on September 2023 Jim passed away. Shortly thereafter I contacted Cari by phone and email to give my condolences and told her that if Jim's plan was still feasible, that I would like to know what it was to see if maybe I could carry it out. We corresponded back and forth for about a month, and she would always tell me she would get back to me, but I never heard back from her, my last attempt done on January 14, 2024.

So, it appears that Jim took the plan, which never became operational, to the grave. Who knows if he got any other person interesting in taking such a risk to their lives to bring MMS to the world; and apparently, Cari is not interested in having any part of it. Maybe they both decided that it was just too dangerous, especially after Mark Grenon and his sons were arrested. Somewhere on Jim's website I believe I read that they had been warned by US authorities about their activities and possible consequences, but I cannot find the quote. Jim's age and health could have also been a contributing factor, as at the time of his last email to me he was 86-87 years old. It is not up to me to judge Cari for not wanting Jim to share the plan with me initially or after Jim's departure. All I can say is that it was a shame, as this plan and any possible positive result would have become known to the world before COVID-19 hit, and that could have thwarted the whole

Plandemic the world was forced to live through, because there would have been a cure to deal with COVID-19, so the vaccines would have not received the Emergency Use Authorization.

One the other hand, if the plan was as powerful and dangerous as Jim anticipated, and we would have proceeded with it, maybe Jim, Cari and I would have ended up in prison or dead as the other assassinated doctors that Jim mentioned (see [Unintended Holistic Doctor Death Series: Over 100 Dead](#)), and therefore, maybe not going forward with the plan was a blessing from God, and our lives were spared. Maybe the world was not ready until today, when Dr. Kory is introducing MMS/Chlorine Dioxide to a world-wide audience of the general public and highly educated members of academia and the medical sciences who follow his work. Only God knows why things turned out this way. Thus, I thank you my Lord, for how it all played out, for the better. Amen.
