RE: Assistance with San Diego City Council

Dear Juan,

I had the pleasure of meeting you and your family around 1992 when you ran for the 50<sup>th</sup> Congressional District. My employer at the time, Action Cleaning, had me assist you with organizing several fundraising events for your campaign. I remember preparing an invitation for a meeting at Chuy's restaurant in Barrio Logan.

Ralph Inzunza provided me your biography, asking that I use it to do a bio section in the invitation. I remember reading how you used to clean chicken dung in your father's barn. Ralph insisted on using this to prove your humble beginnings, but I did not agree and did not include it, because I saw that as something negative that people in high places and against you could use to ridicule you. I also remember reading how you were a Jesuit, and having spoken to you on several occasions I could see that you were a humble, honest and good hearted person.

Now as U.S. Representatives, in a sense, you have gone back to your beginnings, as you are working around political dung and as before you have to raise yourself above it. Like you, Ron Paul, Dennis Kucinich and others, I know that we have men of principal and solid moral character in government that really care for the people they represent and their families, and that will not let themselves be smeared by the dung of corruption, of money and big interests. Because of this I now turn to you for help.

There are many issues that confront our community, our states, our nation and our world, that impact every single human being's life, health and financial standing. So let me give you a brief background.

While aircraft flying at high altitudes of 30,000 ft. and above sometimes create "contrails," which are made of water condensation resulting from the aircraft's heat exhaust, and which contrails last for a few seconds or minutes and usually disappears at the same rate the aircraft travels, we now have a phenomenon referred to as "Chemtrails," something new to our skies and which have been increasing in regularly and extend exponentially in the last 15 years, in our area and across the world.

Chemtrails are believed to be purposefully made trails of chemicals being sprayed in the atmosphere for unknown or undisclosed purposes, which appear as lines behind some aircrafts and which then last for hours and even expand becoming large clouds and finally a sky-covering mist. Among the chemicals believed to make up these chemical trails are aluminum and barium, both detrimental to vegetation and human health.

The following photo shows you the typical contrail, something you have probably seen many times before in your youth.



The following photos I took show chemtrails being sprayed over Chula Vista this November, where I live, where you have one of your headquarters and staff and were you might still live (I visited your home in the 90's, on the east side of Chula Vista if I remember correctly):



In the second set of photos above you can see how these chemtrails above my home expand over time to turn into a cloud/mist. The contrails of an aircraft whose fuel's moisture is creating contrails could never be of such volumes as to create something as expansive as this, something the San Diego APCD claims, unless it is made up of other chemicals that may also be creating a reaction with water particles.



As a note, my home is right next to the 805 and Orange on the West Side, these chemtrails are falling on the East side, right on your back yard.

There are many theories as to who is doing and ordering this and why. Some include actions taken for global warming, geoengineering, weapons aspects, communication reasons, or more alarming, natural vegetation chemical exposure for purposes of patenting genetically modified crops that are resistant to such chemicals being sprayed, to the purposeful attack on human health to “dumb down” the masses for better control and to create more sickness for purposes of selling more medicines and medical services to cure us from the resulting exposure to such harmful chemicals, to depopulation. No matter how sound or outrageous any of these claims may be, the truth is, for whatever reason, the spraying of such chemicals as noted above or any similar heavy metal and toxic substances, has been scientifically proven that it will eventually affect our environment and subsequently our health and our quality of life.

Those people that are complaining of these chemtrails are not only pointing at the new alarming paintings in the sky, but to observations in vegetation and marine life that are being affected, are pointing to testing done of soil and water that show the unnatural large quantities of these chemicals in our environment.

In order to investigate this and try to have it stopped in our community I am planning on bringing up the chemtrail issue before the San Diego City Council. I have already written all council members and none of them are responding. Some of them even denied receiving my email/letter until forced to reproduce them and even then don't show interest. We know they can bring this up on their own motion.

Juan, we know that if indeed chemtrails are a result of what I have described, that there is no way that the federal government is not aware of it, if not participating and encouraging it, so we are up against a very strong foe, that has all the financial backing of the big corporate interests involved in such massive spraying, that have our economy in shambles, and our wellbeing, privacy and liberty in the balance.

According to federal and local government agencies, there is no large-scale spraying of chemicals being done, for any reason, including climate engineering; they say almost all research has consisted of computer modelling or laboratory tests. Yet interestingly, at the federal level John Holdren, Assistant to the President and Director of the White House Office of Science and Technology Policy and Co-Chair of the President's Council of Advisors on Science and Technology, the Science Czar, who is a known proponent of population control and depopulation, has raised with the president the possibility of "massive-scale technological fixes to alter the climate known as geo-engineering." And knowing government, this could mean they have already done it and will continue to do so until exposed and confronted publicly to explain what they are doing and why.

Have we not seen of late time and time again that when something is exposed, like in the case of Snowden, that such thing is denied by the government and then shortly thereafter it is confirmed as true? And assuming it is, geo-engineering guru David Keith admitted in a San Diego symposium on geo-engineering around 2009 that, as to the consequences of spraying 10 megatons of aluminium in the atmosphere, in any geo-engineering aerial spraying, he and the governments/institutions he represents have not seriously studied and researched it and further stated that "... **there could be something terrible that we may find tomorrow**" as to the consequences of such spraying. And yet, he and such institutions are proponents of using aluminium at such quantities for such climate control purposes. See link above, "What in the World are they Spraying," at minute 9:40. If you help us with this and you become a strong advocate, there is no question that your career will be in the balance, that you will find yourself with fierce opposition that will try to discredit you. So you have to decide what is more important to you: your family and the community you represent or your secured career in government, with all the corrupt perks that come with it, especially when a politician is silent about injustices they encounter and the people and organizations behind them and does nothing about it; or worse, helps to protect the corruption and to perpetuate their lies and deception.

Juan, if there is something that the story of Jesus tells us, it is that we must always do the right thing, no matter what the consequences. It is time to step up to the plate. Please join me in first trying to find out at the local level if the spraying of chemtrails is happening; we can worry later about the who and why, as well as any federal actions we can take, such as using FOI requests to federal agencies.
