Dear Peggy, September 8, 2024

I have been following everything you have recently put out on Bobby and Del, and you have great question, and comments, just like I had concerns with Del's vax confidence bill. While I agree with some of your statements, I feel that because of the backlash that you have mentioned you have had, that maybe you have stepped out of an objective role and may be making them pay for the attacks you received. Therefore, in the spirit of the friendship and respect that I have for you and often express, as a friend, as a pastor giving advise to those that may need it, and as a Pastor protecting all children of God, I want to share my thoughts after careful review of all your statements on this matter, and I pray both that God will guide me in using the right word to avoid any misunderstandings, as you, David and I have the same mission.

What prompted me to write this is when I read the following statement you made:

"In 2022, the Children's Health Defense received \$22.5 million in contributions. How much of that came from pharmaceutical companies? **And how can we trust the information coming from an organization funded by the very companies it claims to oppose**?"

Your question is a valid one, but it was the statement that followed that I believe changed it from a question to an accusation. I saw you posted an inquiry in 2023 about their donations and that they did not provide the info, but that is not surprising to me; just like people that have questionable doners that may have bad intent (like you imply Big Pharma is doing with CHD) hide it, and organizations like CHD and ICAN could decide to conceal it, like when the dishonest/fake media may try to find out who donates to you so they can discredit and attack them.

Unless at a minimum someone of an honorable character has told you, or you have direct evidence that CHP is getting pharma money, I think the implication should not be made.

The other thing that prompts me to write this letter was your comments on Dr. Brian Hooker, who I personally know and correspond with. He is a kind man with noble intentions. By the way you referred to him it gives me the impression that you do not know his background, which I will summarize as follows: Without Brian, today's anti-forced vaccination movement would not exist!



So let me begin my comments with a history of our modern-day vax movement, as I don't recall you being on the scene when California's AB 2109 and 2-3 years later SB 277 where signed into law (sic, only a court can declare what the law is) by Gov Brown, 2109 around 2011 and 277 on June 2015) completely removing personal and religious exemptions.

Around 2014 Bobby put out the book, Thimerosal: Let the Science Speaks, which exposes mercury in vaccines and the harms caused by it, including autism. There had been several documentaries around that time exposing vaccines, including *Vaccine Nation* (2008) and *Trace Amounts* (2014), but none of them got any traction by the media. And if the media does not mention it, it does not exist.

The one thing about *Trace Amounts* is that it introduces Dr. Hooker. He has a son with severe autism and for years submitted FOIA requests with CDC for info because he knew that the vaccine(s) caused his son's injuries. And then one day, Dr. William Thompson, one of the head CDC scientists in the area of vaccines, calls him and confessed that they did a study, that it showed the MMR vaccine caused autism, that they were told to recalculate all results to get to a negative result, that they were ordered to destroy the incriminating info – and that he kept a copy. He further stated that he felt responsibility for Hooker's son and would provide him all the data. This was a side note towards the end of *Trace Amounts*, and it stayed buried, until Dr. Andrew Wakefield and Del Bigtree came out with *Vaxxed: From Cover-Up to Catastrophe*, which is based on Dr. Hooker's story, because, as it turns out – they recorded Thompson confessing. Vaxxed would have gotten buried, just like the others, except that they were going to show it in Robert De Niro's Tribeca Film Festival for openers and under pressure they pulled it (supposedly without De Niro's approval). Had the press not made an issue, that would have been that, but like a gift from God, NBC's morning show Today decided to interview him and to use it to get him to discuss it and to discredit the film, defending vaccines. Turns out, De Niro's son is vaccine injured, and De Niro spill it out, recommending the film and mentioning *Trace Amounts*. Regardless of his comments in favor of *Vaxxed*, De Niro did not play the movie due to pressure from advertisers and donors. Important side note: not long after that, I think it was that De Niro with Bobby and the vaxx team offered something like \$100,000 to anyone that could prove that vaccines were safe. There were no takers. Since then, De Niro has gone to the dark side. God works in mysterious ways. Here is an article on that,

So Wakefield, Del, Polly Tommey and their crew, as an alternative, got a chain to premier their movie, but instead of opening it at the same time nationwide, they got themselves a large buss,

painted the movie logos on it and hit the road through the U.S. being at the opening in each city for Q&A. Because the movie was about the MMR vaccine, they expected to find some children that were affected by it. To their surprise, they found adults and children injured and killed by all the vaccines. Their bus had a black background. Someone had the idea to bring a permanent marker so people could write the names of the injured. It is eye opening!



SB 277 passed On 2015 and from there other states started to try to pass similar laws. Thanks to Dr. Hooker, Del and *Vaxxed*, which came out, in 2016, all the mothers in California that had a coalition fighting against these mandates found a home to grow, with Del, Bobby, and many other groups that were coming out from all around the country, most of us communicating via Facebook.

When Del and the Team travelled and collected the signatures in the bus, they also interviewed all those affected, and that resulted in probably the most important of all vax documentaries, *Vaxxed II: The People's Truth*, when Producer Polly Tommey took the existing interviews and conducted more, giving us the true story of the devastation being done to all by Big Pharma, the whole medical industry, and all health authorities at all levels in a conspiracy to promote and force vaccines of their choice on all of humanity. Unfortunately for this movie, as soon as it came out, shortly thereafter we had the CV mandates that closed theatres and buried it in history. I highly recommend it. While it's true that neither Bobby or Del made any lawsuits when SB 277 came into effect, there were 3 cases, state and federal that challenged it, but none of them were successful. I was indirectly involved in all of them, and I think infiltration played a role in their defeat. After that both Bobby and Del participated in multiple events across the country defending freedom of choice and complete opposition to mandates.

While Bobby's CHD has exposed many environmental and medical dangers, it has been through writings and some lawsuits (they fought the NY Jewish measles outbreak mandates). Del's live weekly *The Highwire* broadcast became the hub for the latest in the vaccine fight, now expanded to many other topics of information. I have been watching it for probably about 5 years. They also followed a strategy I followed from the beginning in filing FOIA requests to get a better understanding of what was going on. My experience has been of always getting a pushback to release info and remove redactions, luckily for them they have the financial means via donations to bring lawsuits to force them to release info, a lot of it being used in multiple

lawsuits against Big Pharma and gov agencies now, like the info on the CDC's V-Safe database on CV-19 injury that the government tried to suppress. Dr. Hooker's latest work was with Bobby writing the book *Vaxxed-Unvaxxed*: *Let the Science Speak*, showing that the unvaxxed are healthier. Regardless of Bobby's comments on "safer vaccines" this goes to the heart of his message to humanity: vaccines injure, avoid them! No matter how we spin it, it boils down to this. Like Trump, he may be behind Warp Speed, but he always said, there are therapeutics that are probably better, mentioned Hydroxychloroquine, and clearly said it should be your choice to mask and vax, or not. Peggy, I think you are not really taking all of this in consideration when evaluating if Del, Bobby, and Kirch have sincere intentions, although they may be misguided. When I wrote my letter to Del on his vax confidence bill before you did, I clearly showed how bad that whole bill was, from the name to the content, but I approached it from the side of all that they have done to create this modern-day vax movement, all I have learned from them and have applied in my work, and noting where I disagree, but always commenting in good faith.

Comparing your initial questioning of Del and Bobby's work, to your comments today, there is a clear slide from fact finding to negative implied solid conclusions. This is my personal opinion. But I will make this clear: I know you have the best intentions in mind and do it seeking truth. Let me just address a few things before closing. Being that the way you are communicating all this RFK Jr info is from a stance of suspicion towards the negative, let me play devil's advocate on the other side of the equation.

As to your comments of JFK's Vaccine Assistance Act, the 1020's book Horrors of Vaccination showed how health officials where involved even then in vax injury cover up, but the general public did not know. Similarly in JFK's times in the 50/60's, like today prior to *Vaxxed*, many did not know the truth of vaccine danger and believe the government/media narrative.
