Any federal legislation and/or executive order must allow exemptions to vaccination for any purpose and activity, for any adult and those in their care for personal, medical, philosophical, and religious reasons. I request this for the following reasons:

## VACCINE INJURY

Thanks to the actions of HHS Secretary Kennedy, information regarding the dangers of vaccines, including many medical studies, which were hidden from the public in the past, have confirmed without a doubt that vaccines can cause injury, from minor ticks, to debilitating neurological problems, that can include autism, and can even cause sudden infant death syndrome (SIDS) and death. The main point that has been outlined by Secretary Kennedy is that no vaccines have ever been tested against actual true saline placebos, and instead have been tested against other vaccines, making it impossible to determine if the vaccines cause any injury in those involved in the related studies. By mere logic, if they have never been tested against a true placebo, it is impossible for any reasonable person, even researchers, to state that vaccines do not do harm, especially when you have thousands of parents of healthy children. who took them to a pediatrician, he/her declares them to be completely healthy, and after the vaccine they become seriously ill or die within hours and/or weeks. Because the potential of vaccine injury undoubtedly exists, there must always be a personal and medical exemption for vaccination.

## RELIGIOUS EXEMPTION

At a minimum, any legislation and/or executive order must include a religious exemption to vaccination base on our God-given rights as expressed in the Declaration of Independence, and as reflected in the First Amendment to the U.S. Constitution.

From a Christian standpoint, the Bible instructs all Christians to avoid vaccination. This can be verified by the Biblical passages below. This includes the issue that (1) vaccines contain DNA from healthy aborted fetal tissue; (2) which unborn child was murdered; (3) that our body is the Temple of God and we are not to defile it; (4) that vaccines contain ingredients including those that come from animals and insects, ungodly unclean, injected directly into our bloodstream; (5) that they contain neurotoxic substances, like mercury and aluminum that can seriously negatively affect their mental state, which would limit their ability to worship, or even understand who God is and what He means in their lives; and (6) that God clearly tells us that wicked people will try to force us to disobey God and not protect our body, The Temple of God, from toxic vaccines, the “darts” the Bible tells us to be aware of, that can affect our spiritual relationship with God, our Creator and Master.
