**RE: RICARDO BEAS' INFORMAL PERSONAL REQUEST
UNDER THE FIRST AMENDMENT TO THE
U.S. CONSTITUTION: THE RIGHT TO PETITION
THE GOVERNMENT FOR A REDRESS OF GRIEVANCES¹
-- IT'S TIME TO OVERTURN JACOBSON**

Honorable Justices of the U.S. Supreme Court,

Our country's principles of fairness, justice, and separation of powers have been reaffirmed by today's Court majority by the actions it has taken to overturn the historical precedent set by previous case law, like *Roe* and *Chevron*, due to inappropriate application of the law and/or additional present-day information that makes your new rulings distinguishable from some in the past. Although I do not agree with all the decisions of the majority, I am happy to see how this Court has corrected injustices, wrongfully interpreted findings of fact and conclusions of law in such cases.

It is with the above in mind that I ask you to take up any petitions for a writ of certiorari related to vaccine mandates or similar cases submitted to this Court and to use them for once and for all overturn *Jacobson v. Massachusetts*, 197 U.S. 11 (1905), and forever establish that men and women and those under their care under any circumstances have an absolute right to refuse any vaccine mandate or medical procedure against their will, be it based on personal, philosophical, medical, and/or religious beliefs. I base my request on the following:

1. Today's lawsuits related to vaccines have to do with individuals claiming their right to be vaccine-free for any reason, whether to attend school, work, participate in the military, or participate in social and community events, and may include in the future the ability to buy

food, have bank accounts, leave their home, or be quarantined and jailed. *Jacobson* only had to do with paying a \$5.00 fine. This alone should make *Jacobson* distinguishable from lawsuits brought up in recent times.

2. The *Jacobson* court noted two important things in their ruling that form the basis for their conclusion that the government can issue and enforce vaccine mandates:

(a) *“There is, of course, a sphere within which the individual may assert the supremacy of his own will and rightfully dispute the authority of any human government, especially of any free government existing under a written constitution, to interfere with the exercise of that will.”*

(b) *“But it is equally true that, in every well ordered society charged with the duty of conserving the safety of its members the rights of the individual in respect of his liberty may at times, under the pressure of great dangers, be subjected to such restraint, to be enforced by reasonable regulations, as the safety of the general public may demand.”*

I contend that present-day government-imposed vaccine mandates and court rulings allowing them are not only unreasonable, excessive, arbitrary capricious, and an abuse of discretion, but also that such vaccines, from those in the Centers for Disease Control and Prevention’s (CDC) childhood and adult vaccine schedules to the COVID-19 injections, mislabeled by health agencies as vaccines, pose a **Great Danger** to the **General Public**, up to and including death, as will be proven herein.

This Court must always keep in mind that, as to **Natural-Born Men or Women, Children of God All of Them**, who are not fictitious entities, fictions created by the State, which the State may refer to as *“human beings not acting as an agent or official of a business entity (e.g., company, corporation, partnership),”*² and as based on the **Holy Bible**, the **Natural and Common Law**, and as noted in *Hale v. Henkel*, 201 U.S. 43 (1906), such men and women are ...

*“Entitled to carry on his(her) private business in his own way. His power to contract is unlimited. He owes no duty to the State or to his neighbors to divulge his business, or to open his doors to an investigation, so far as it may tend to criminate him. He owes no such duty to the State, since he receives nothing therefrom beyond the protection of his life and property. His rights are such as existed by the law of the land long antecedent to the organization of the State, and can only be taken from him by due process of law, and in accordance with the Constitution,”*³ as well as all precedent-setting legal historical written documents, from *Hammurabi’s Code*, the *Holy Bible*, and the *Magna Carta*, up to and including the *Nuremberg Code*, regardless of whether the United States is a

signing party to that international agreement,⁴ such men and women not having any substantial relationship with and/or nexus with the state.

Combining the above two statements from *Jacobson*, the court concluded that while an individual may have a right not to vaccinate, that right can be denied if it is best for the general public. And we can dissect this even more and say that the decision in *Jacobson* assumes that health agency representatives are honest, that vaccines are effective, meaning they cure or prevent disease, and safe, meaning they don't cause harm, or at least not commonly, but none of these things are true: vaccines are neither effective or safe, and vaccine manufacturers and government health agencies in collusion with others know this and yet hide it from the public, denying vaccine harm, even though their own data overwhelmingly proves otherwise, followed by government censoring and attacks against those against the forced vaccination agenda, like myself. Just like a newspaper article whose title reads "*Man Committed Suicide*," only to read in the last paragraph that he was found with three shotgun shots to the head, so too the CDC and other U.S. Department of Health and Human Services (HHS) operating divisions and agencies claim that vaccines are safe when nothing can be further from the truth, their own data and/or lack thereof proving otherwise.

3. Vaccine mandates have been in place for many decades in the United State, going back to the early 1900s. In those days, like today, the manufacturers of all existing vaccines failed to disclose all the potential minor, serious and deadly harm that could be and was being caused by their products, as was well documented by the 1920 book by Chas. M. Higgins, "*Horrors of Vaccination Exposed and illustrated*," and other similar writings of the time. Read Higgins' book, at <https://tinyurl.com/Horrors-Vaxx-Higgins>.

4. With the advent of the public's right to Freedom of Information Act requests, combined with the emergence of the internet, where research can be easily done to get data from all over the world, regarding fraudulent and harmful pharmaceutical industry practices, as well as data linking vaccines to serious injuries and fatalities, we can now uncover the truth about vaccine harm, as has been uncovered by the research done by advocates against forced vaccination, like Dr. Sherri Tenpenny, Dr. Suzanne Humphries, and scientists Judy Mikovits and James Lyons-Weiler, as well as reporting done by news organizations like the *Informed Consent Action Network* (ICAN) and the Children's Health Defense. To this end, I personally have also gathered all the information necessary, including my own studies, to prove that vaccines are harmful and that vaccine manufacturers and our health agencies are well aware of this. 5. The most convincing evidence that vaccine manufacturers and our health authorities, who work in unison, are corrupt and in the process are affecting the **Safety of the General Public**, as referenced in *Jacobson*, is the CDC's corruption uncovered by the *Informed Consent Action Network*, headed by Del Bigtree, who through their attorney Aaron Siri, fought the CDC for over

a year trying to get the CDC to release information from the V-Safe COVID-19 data collection database, which they did through a Freedom of Information request.


The CDC set up a voluntary user-run reporting system where those that received the COVID-19 injections could report any adverse health impacts. The system is known as “V-Safe”.⁵ According to a report done by ICAN’s *The Highwire* on or around October 7, 2022, through a FOIA request and after a year of legal filings and lawsuits, the CDC reluctantly provided them participant information from that system, dating from December 14, 2020, to July 31, 2022.

ICAN created a database with the information provided by the CDC, and they found the following:

TOTAL INDIVIDUAL USERS:	10,108,273	
TOTAL INDIVIDUAL IMPACTS:	3,353,100	(33.17%)
TOTAL HEALTH IMPACTS:	6,458,751	(63.89%)
UNABLE TO DO NORMAL ACTIVITIES:	1.2 MILLION	(11.87%)
MISSED WORK OR SCHOOL:	1.3 MILLION	(12.86%)
REQUIRED MEDICAL CARE:	782,913	(7.74%)



The problem was, the V-Safe system was designed specifically to only capture minor and general medical issues, there were no checkboxes for serious events, like those listed as known in vaccine inserts (noting that the COVID-19 injections insert was fraudulently left blank). See screenshots on the right.



For example, it asks the participant to note simply Yes or No if they had fever but does not ask how high the fever was or for how long. It asks if they had any injection site symptoms, like pain, redness, swelling, and itching, but does not ask to what degree and where.

For symptoms, it has check boxes that only ask the participant for the following: chills, headache, joint pain, muscle or body aches, fatigue or tiredness, nausea, vomiting, diarrhea, abdominal pain, or rash, but again does not ask to what degree, and does not include other very serious symptoms reported in the COVID-19 injection studies, such as those listed in the Pfizer vaccine study titled, “Cumulative Analysis of Post-Authorization Adverse Event Reports of PF-07302048 (BNT162B2) received through 28-Feb-2021,” where in Appendix 1, titled “List of Adverse Events of Special Interest,” it provides 9 pages of single-spaced, back to back, injuries,

including many serious injuries listed in the CDC Vaccines inserts, which I listed above.⁶ Further, **in these checkboxes they did not include myocarditis or heart attacks, which the manufacturers and the CDC knew have been associated with the COVID-19 injections and which have skyrocketed in the Vaccine Adverse Event Reporting System (VAERS) system since their rollout.**

For Health Impacts, it asks if the participant was unable to work, unable to do normal activities, or required medical care, but again not how severe or how long that impact was. In all these outcomes noted, the V-Safe system could have easily added check boxes for each of these symptoms to determine seriousness, but it was, I believe, purposefully omitted.

It took the CDC 463 days from the time the data was requested by ICAN for the CDC to produce the data, but they did not provide all the information. In a further attempt to hide serious injuries, the CDC did not release the information that was provided by the participants in an open text field (fill in the blank box) titled “Any Other Symptoms or Health Conditions You Want to Report,” where more detailed information could be provided of not only the extent of the health impacts, but the specific medical problems suffered by the COVID-19 injections recipients.⁷

When the CDC established this tracking system, they announced that they would make the V-Safe data available to the public, but they have not published it in over 2 years. In the CDC letter/email to ICAN where they released the information, they noted that they had not released the data to the public because they had not completed the technical and administrative process required to post the data. With billions of dollars at their disposal, this is a flat out lie, as it took ICAN **less than one week** to create an active database to research all the data, as noted on the ICAN V-Safe Data searchable database screenshot above. The actions by the CDC are fraudulent and criminal in magnitude. Here is what the CDC wrote on their letter to ICAN to try to justify hiding the COVID-19 injections injury information:

The agency originally planned to post these datasets on CDC’s website on or before September 30, 2022. However, the agency has not yet completed the technical and administrative processes required to post data on a CDC.gov site. The agency is therefore releasing these datasets directly to you.

Thanks to ICAN's persistence in their lawsuits, U.S. District Court judge Matthew J. Kacsmaryk from the Northern District of Texas ordered the CDC to release all the data,⁸ and it has been releasing the data in scheduled productions, proving irrefutably the frequent harm by the COVID-19 vaccines, some reactions within minutes, hours and days of administration. Who knows how many of these volunteers did not report further because they died as a result of the Big Pharma/CDC's fraud. There are multiple social media sites dealing with persons that "**Died Suddenly**," one showing thousands of person's social media post boasting that they got the vaccine for **the Safety of the General Public**, only to die unexpectedly in their sleep soon thereafter,⁹ or simply dropping dead, like we've seen with athletes since the COVID-19 vaccine rollout.¹⁰

6. The 1st Amendment to the U.S. Constitution clearly states that the people have a right to practice their religious beliefs in the way they see fit, and that the government will not be involved in "prohibiting the free exercise thereof," which includes refusing vaccination because it is against their religious principles, beliefs and practices.

7. The 4th Amendment to the U.S. Constitution states that we have a right to be "secure" of our person, our body, the word secure encompassing to be safe and free of harm, and not exposed

to danger, and that we have a right to reject things that are repugnant to our moral and spiritual beliefs, not allowing us to have our bodies' seized by any government agent in order to participate in such unsecure and potentially harmful interactions. Further, we have a right to self-preservation from the real, frequent, and proven harm and danger that results from vaccination, and therefore the right to avoid the potentially associated injury from a real, existing and proven danger, as confirmed by the vaccine manufacturers' own studies and documentation. *"No one can give up those rights that are necessary for self-preservation: the right of resistance or the right of self-defense."* Eleanor Curran.

8. The 9th Amendment to the U.S. Constitution states that "the enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people," like the right to bodily independence, freedom of choice, and informed consent.

9. The U.S. Declaration of Independence makes it clear that our rights come from and where lovingly given to us, in the form of Free Will, by God, who allows us to live our lives as we please, so long as we do not intrude on other's rights, as reflected in the Common Law.

10. This Free Will, given to us by God, and which must be respected by all levels of government, as reflected by the Declaration of Independence and the 1st, 4th and 9th Amendments to the Constitution, as outlined above, confirm that we also have a personal and philosophical God-given right to refuse vaccination and other medical procedures based on such rights, regardless of whether a person believes in God or not, God being the creator of all things, and God granting this right to all His Children.

Therefore and otherwise, I request that this Court be open to accepting petition's for writ of certiorari related to the right to refuse vaccination, that it take into account all the information provided herein, and that it overturn *Jacobson* as no longer applicable based on the overwhelming evidence that vaccines are not safe and effective, but on the contrary are highly toxic, harmful from minor to serious injury, including death, that such harm happens often as proven in the example of the COVID-19 V-Safe data, and that therefore, vaccines pose a **Great Danger to the General Public**, and that any regulations attempting to forced them or make them compulsory are **Unreasonable Regulations**. I respectfully request a signal from the conservative justices in this court, for example, that this Court is ready to rule on *Jacobson's* applicability today by granting a petition for writ of certiorari to any relevant vaccine mandates case.
