Dear President Trump,

I write you today to thank you for your stance on vaccines and the ultimate right that all persons and their dependents have to avoid such medical procedures, or any other, including masking. I have written a proposed bill, to be introduced in both state and federal legislatures, to bring an end once and for all to the issue of whether the government or any other person or entity can force anyone to subject themselves to any medical procedure against their will, for any reason, be it personal, philosophical, medical or religious.

I ask you and pray that you will share the text of my bill with your staff, loyal federal and state senators and congressman, and governors, who are also believers and champions of the universal right to self-determination and freedom, at all levels. Here is my bill, subject to changes as may be necessary to help to get it passed.

**TITLE: THE RIGHT TO SAY NO TO VACCINATION BILL**

**PURPOSE:** Assures the public that any person on their own behalf or on behalf of the person's child or dependent will always have the legal right to a vaccine exemption, to any vaccines or

similar medical interventions, past, present, and future, based on personal, medical, philosophical and/or religious beliefs.

**JUSTIFICATION:** Adding such unlimited rights to choose whether to vaccinate or not will remind both the government and the people of this great Republic that our rights come from God, that this is confirmed in the U.S. Declaration of Independence, and that it is reflected in the U.S. Constitution, in the 1st, 4<sup>th</sup> and 9th Amendments, all in accordance with the Common Law (optional) and the ultimate Law of the Land, The Holy Bible, God's Law.

*(PRB Note: As to the above statement about the Holy Bible, if used, all as proclaimed by the Catholic Church, who through Papa Bulls authorized European nations to conquer America, and set up all corporations to run such operations. Being the Parent Company, the Catholic Church is the highest authority over all these nations and their governments, their corporations, and the de jure and de facto entities that grew around them. #### **TEXT: ELIMINATION OF ALL VACCINE MANDATES**

A. Vaccine mandates have been in place for many decades in the United State, going back to the early 1900s. In those days, like today, the manufacturers of all existing vaccines failed to disclose all the potential minor, serious and deadly harm that could be caused by their products, as was well documented by the 1920 book by Chas. M. Higgins, "Horrors of Vaccination Exposed and illustrated," and other similar writings of the time. Read Higgins' book, at <https://tinyurl.com/Horrors-Vaxx-Higgins>.

B. With the advent of the public's right to Freedom of Information Act requests, combined with the advent of the internet, where research can be easily done to get data from all over the world, regarding fraudulent and harmful pharmaceutical industry practices, as well as data linking vaccines to serious injuries and fatalities, we can now uncover the truth about vaccine harm, as has been uncovered by the research and news reporting done by news organizations like the Informed Consent Network and the Children's Health Defense.

C. The 1st Amendment to the U.S. Constitution clearly states that the people have a right to practice their religious beliefs in the way they see fit, and that the government will not be involved in "prohibiting the free exercise thereof," which includes refusing vaccination because it is against their religious principles, beliefs, and practices.

D. The 4th Amendment to the U.S. Constitution states that we have a right to be "secure" of our person, our body, the word "secure" encompassing to be safe and free of harm, and not exposed to danger, and that we have a right to reject things that are repugnant to our moral

and spiritual beliefs, not allowing us to have our bodies' seized by any government agent in order to participate in such unsecure and potentially harmful interactions.

Further, we have a right to self-preservation from the real, frequent, and proven harm and danger that results from vaccination, and therefore the right to avoid the potentially associated injury from a real, existing and proven danger, as confirmed by the vaccine manufacturers' own studies and documentation. "No one can give up those rights that are necessary for self-preservation: the right of resistance or the right of self-defence." -- Eleanor Curran

E. The 9th Amendment to the U.S. Constitution states that "the enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people."

F. The U.S. Declaration of Independence makes it clear that our rights come from and where lovingly given to us, in the form of Free Will, by God, who allows us to live our lives as we please, so long as we do not intrude on other's rights, as reflected in the Common Law.

G. This Free Will, given to us by God, and which must be respected by all levels of government, as reflected by the Declaration of Independence and the 1st, 4th and 9th Amendments to the U.S. Constitution, as outlined above, confirm that we also have a personal and philosophical God-given right to refuse vaccination based on such rights, regardless of whether a person believes in God or not, God being the creator of all things, and God granting this right to all His Children.

H. The public shall be informed, and the government will respect and abide by the fact, that a person may claim a vaccine exemption to any and all existing and future vaccines, for personal, philosophical, medical and/or religious reasons on the person's own behalf or on behalf of the person's child or dependent, under all circumstances, and that the department or any other state agency, board or commission may not require the person to meet any condition or requirement to claim and be granted such a vaccine exemption.

I. The Right To Say No To Vaccination shall include and extend to any verbal or written declination or refusal to vaccination for any purpose, including but not limited to any condition of employment, school attendance, license, certification or degree, visiting any public or private place, participating in any social or community activity, visiting any entertainment venue, visiting any restaurant, buying a home or renting an apartment, medical emergency, getting care in any medical establishment, traveling for any purpose without the need of a vaccine passport inside or outside of the United States, any right to purchase in person or online any tangible or intangible items, access to the internet, or receive any other public or government provided services.

J. In the same fashion that all men and women have a right to say no to vaccination for any reason, in particular because of vaccine's proven health risks, so too all men and women have

God-given, unalienable rights to control and maintain their personal and spiritual health; thus they have the right to refuse to participate in any or all medical procedures, such as masking, chemotherapy, toxic medications, psychiatric and mind altering medications, DNA/RNA-modifying substances, X-rays, scans, microchip implants, robotic nanotechnology particle exposure, tracking tattoos of any sort, or health insurance mandated by any human government authorities in the Land or Sea Jurisdictions. Further,

K. All men and women have a God-given, unalienable right to choose, cultivate, grow, mine, accumulate, produce, and use substances and products for their health and spiritual wellbeing, including but not limited to: food stuffs of any sorts grown naturally or otherwise, plants, vitamins, minerals, salts, herbs and all remedies, homeopathic, natural, or otherwise, in any quantities that they consider useful or necessary for their personal and spiritual health, the health of their family, and to share with all that desire help with their health, and they have the right to maintain such substances and products at their place of abode or wherever they deem necessary, and in any quantities they deem fit. Government cannot interfere with any person's right to try any medications they deem appropriate for them, experimentally or otherwise.
